19	To amend, on a temporary basis, the Early Childhood Educator Pay Equity Fund
20 21	Establishment Act of 2021 to authorize the Office of the State Superintendent of Education to create a grant program that supports pay parity for early childhood
22	educators in accordance with the recommendations of the Early Childhood
23	Educator Equitable Compensation Task Force and to enter into a sole source grant
24	agreement for the purposes of implementing this program.

26	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
27	That this act may be cited as the "Office of the State Superintendent of Education Pay
28	Parity Program for Early Childhood Educators Authorization Temporary Amendment Act of
29	2022".
30	Sec. 2. Section 5102 of the Early Childhood Educator Pay Equity Fund
31	Establishment Act of 2021, effective November 13, 2021 (D.C. Law 24-45; D.C. Official
32	Code § 1-325.431), is amended as follows:
33	(a) Subsection (c) is amended as follows:
34	(1) Paragraph (1) is amended by striking the phrase "; and" and inserting a
35	semicolon in its place.
36	(2) A new paragraph (1A) is added to read as follows:

37	"(1A) With funds appropriated in Fiscal Year 2022, create an early
38	educator pay parity program that will provide direct payments to employees of early
39	childhood development providers in accordance with the recommendations of the Early
40	Childhood Educator Equitable Compensation Task Force reports submitted to the
41	Council on January 15, 2022, and by April 15, 2022; and"
42	(3) Paragraph (2) is amended to read as follows:
43	"(2) Pay agency administrative costs related to implementing the early
44	educator pay parity program authorized in paragraph (1A) of this subsection or increasing
45	the minimum compensation for employees of early childhood development providers
46	pursuant to a salary scale passed or approved by the Council, including personnel costs,
47	vendor costs related to distributing pay supplements to early educators, or costs related to
48	providing technical assistance to early childhood development providers; provided, that
49	such administrative costs shall not exceed \$ 5,390,878 in Fiscal Year 2022 and 5% in any
50	fiscal year thereafter of the annual amount deposited in the fund."
51	(a) A new subsection (e) is added to read as follows:
52	"(e) Notwithstanding section 1094 of the Grant Administration Act of 2013,
53	effective December 24, 2013 (D.C. Law 20-61; D.C. Official Code § 325.431), the Office
54	of the State Superintendent of Education may enter into a sole source grant agreement in
55	Fiscal Year 2022 for the purpose of implementing the early educator pay parity program
56	by distributing direct payments to employees of early childhood development providers,
57	as authorized pursuant to subsection (c)(1A) of this section.

59	The Council adopts the fiscal impact statement of the Budget Director as the
60	fiscal impact statement required by section 4a of the General Legislative Procedures Act
61	of 1975, approved October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-307.47a).
62	Sec. 4. Effective date.
63	This act shall take effect following approval by the Mayor (or in the event of a
64	veto by the Mayor, action by the Council to override the veto), a 30-day period of
65	congressional review as provided in section 602(c)(1) of the District of Columbia Home
66	Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-
67	206.02(c)(1) and publication in the District of Columbia Register. This act shall expire
68	after 225 days of its having taken effect.
