On Tuesday, February 8th, 2022, Councilmember Robert C. White Jr., Chair of the Committee on Government Operations and Facilities, will hold a Public Roundtable on the Strategic Plan for the Office of Advisory Neighborhood Commissions. The public roundtable will take place via the Zoom web conferencing platform at 12:00 PM. The purpose of this public roundtable is to hear from Advisory Neighborhood Commissioners and members of the public about what should be considered for inclusion in the Strategic Plan for the Office of Advisory Neighborhood Commissions.

In the Fiscal Year 2022 budget for the Office of Advisory Neighborhood Commissions, the Council budgeted \$100,000 for the office to complete a Strategic Plan and directed the office, working with an outside facilitator as necessary, to organize targeted outreach to Commissioners to identify their priorities for support services and associated training and to develop a Strategic Plan for meeting the priorities identified by Commissioners, including timelines and metrics for measuring success. As the office is undergoing a leadership transition, the Committee is scheduling this roundtable to ensure Commissioner and public feedback can be collected to inform the work of the next permanent Executive Director in completing the Strategic Plan in a timely fashion. The Committee's intent is that this process will also help inform the next budget process for the office.

The Committee invites the public to testify remotely or to submit written testimony. Anyone wishing to testify must sign up at <https://forms.gle/UrkJAKXjGPaQuD8> or by phone at (202) 741-8593, and provide their name, phone number or e-mail, organizational affiliation, and title (if any) by **the close of business on Friday, February 4th, 2022**. Witnesses are encouraged, but not required, to submit their testimony in writing electronically in advance to facilities@dccouncil.us. Witnesses will participate remotely via Zoom. The Committee will

follow-up with witnesses with additional instructions on how to provide testimony in advance of the proceeding.

All public witnesses will be allowed a maximum of four minutes to testify, while Advisory Neighborhood Commissioners will be permitted five minutes to testify. At the discretion of the Chair, the length of time provided for oral testimony may be reduced.

Witnesses who anticipate needing language interpretation, or require sign language interpretation, are requested to inform the Committee of the need as soon as possible but no later than five (5) business days before the proceeding. We will make every effort to fulfill timely requests, however requests received in less than five (5) business days may not be fulfilled and alternatives may be offered.

The Committee also encourages the public to submit written testimony to be included for the public record. Copies of written testimony should be submitted by e-mail to facilities@dccouncil.us. **The record for this public roundtable will close at the close of business on Tuesday, February 22nd, 2022.**
