24 IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

27 To celebrate the achievements of The Museum DC, for its success and commitment to
28 representing DC community and culture.

29
30 WHEREAS; The Museum DC is a Black-owned gallery and boutique located at 2014
31 Rhode Island Avenue NE.

33 WHEREAS; The Museum DC launched in April 2016, founded by native
34 Washingtonians Mr. LeGreg Harrison and Mr. Muhammad Hill.

36 WHEREAS; The Museum DC quickly became a staple of art and culture in the District
37 of Columbia and an anchor in the Rhode Island Avenue Northeast Main Street.

39 WHEREAS; The Museum DC’s motto “Fashion is Art,” has consistently been reflected
40 by the community engagement and creator showcase efforts of Mr. Harrison and Mr. Hill.

42 WHEREAS; in February 2022 The Museum DC designed “The Museum DC x Curry
43 Brand” high top Curry One Retro shoe, a collaboration with Golden State Warriors basketball

44 player Steph Curry and sports brand Under Armour, that highlighted the D.C. area and used
45 colors and symbols from the WMATA Metro.

47 WHEREAS; the shoes are red, blue, orange, yellow, green, and silver to represent the six
48 lines of Metro trains.

50 WHEREAS; Mr. Harrison and Mr. Hill said of the collaboration: “The in-sole was
51 created to inspire inner city kids. Regardless of your path, with many rail options to choose from,
52 our hope is that these metro passes will grant you unlimited access as you travel to the
53 destination of your dreams.”

55 RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
56 resolution may be cited as “The Museum DC Celebration of Achievements Ceremonial
57 Resolution of 2022”.
