17	To amend, on a temporary basis, the Urban Forest Preservation Act of 2002 to authorize the
18	Mayor to issue stop work orders to preserve Special Trees and Heritage Trees.

20	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
21	act may be cited as the "Urban Forest Preservation Stop Work Order Authority Temporary
22	Amendment Act of 2022".
23	Sec. 2. The Urban Forest Preservation Act of 2002, effective June 12, 2003 (D.C. Law
24	14-309; D.C. Official Code § 8-651.01 et seq.), is amended as follows:
25	(a) Section 102 (D.C. Official Code § 8-651.02) is amended as follows:
26	(1) A new paragraph (1A) is added to read as follows:
27	"(1A) "Critical root zone" means the area of soil within a circle circumscribed
28	around a tree's trunk using a radius, measured in inches, determined by multiplying the number
29	of inches in the tree diameter by no less than 18.".
30	(2) A new paragraph (5A) is added to read as follows:
31	"(5A) "Stop work order" means a written notice from the Mayor mandating the
32	cessation or holding of work.".
33	(3) A new paragraph (6A) is added to read as follows:

34	"(6A) "Tree diameter" means the length of a straight line segment that passes
35	through the center of a tree and whose endpoints lie on the circumference of the tree, measured
36	using a tree's circumference 54 inches above the ground level.".
37	(b) Section 108 (D.C. Official Code § 8-651.08) is amended as follows:
38	(1) The existing text is designated as subsection (a).
39	(2) A new subsection (b) is added to read as follows:
40	"(b)(1) In addition to or instead of imposing a civil fine, penalty, or fee under subsection
41	(a) of this section, the Mayor may issue a stop work order if the Mayor finds that any work is
12	being performed, or may be performed imminently, in violation of the provisions of this act.
13	A stop work order under this subsection shall be in writing and in a form prescribed by the
14	Mayor.
45	"(2) A stop work order under this subsection shall contain the following
46	information:
1 7	"(A) The reason for the stop work order;
18	"(B) The conditions under which the cited work will be permitted to

51	"(D) The specific areas of the property and specific activities covered by

- "(5) The Mayor shall lift the stop work order when the Mayor deems that the
 violation or potential violation leading to the issuance of the stop work order has been corrected
 or abated to the satisfaction of the Mayor.
- "(6)(A) No later than 10 business days after receiving notice of a stop work order,
 the property owner or the property owner's agent may request review by the Mayor and shall
 state, in writing, the grounds for the requested review.
- "(B) Upon receipt of a request for review that complies with subparagraph
 (A) of this paragraph, the Mayor shall affirm, modify, or reverse the stop work order within 15
 business days of receipt of the request. If the Mayor does not act upon the review request within
 the 15 business day period, the stop work order shall be lifted. A decision of the Mayor under
 this subparagraph shall be a final decision on the specific issue in the review request.

80	"(7) Before a stop work order under this subsection is issued, the Mayor may
81	issue a warning notice to the property owner or the property owner's agent.
82	"(8) A violation of a stop work order issued under this subsection shall constitute
83	a violation of this act.
84	"(9) Whenever it appears that any person has violated, or is about to violate, a
85	stop work order issued under this subsection, the Office of the Attorney General for the District
86	of Columbia may bring an action in the Superior Court of the District of Columbia for injunctive
87	relief.".

- (a) This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), a 30-day period of Congressional review as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of Columbia Register.
- (b) This act shall expire after 225 days of its having taken effect.
