The stated purpose of PR24-0630, the “Commission on Fashion Arts and Events Eugene Simms Confirmation Resolution of 2022” is to confirm the appointment of Mr. Eugene Simms, a Ward 5 resident, as a member of the Commission on Fashion Arts and Events, replacing Le’Greg Harrison, for a term to end April 15, 2025.

The stated purpose of PR24-0631, the “Commission on Fashion Arts and Events Lanaysha B. Jackson Confirmation Resolution of 2022” is to confirm the appointment of Lanaysa B. Jackson, a Ward 1 resident, as a member of the Commission on Fashion Arts and Events, for a term to end April 15, 2024.

The Committee invites the public to testify remotely or to submit written testimony. Witnesses are encouraged, but not required, to submit their testimony in writing electronically in advance to facilities@dccouncil.us. Witnesses will participate remotely via Zoom. The Committee will follow-up with witnesses with additional instructions on how to provide testimony in advance of the proceeding.

All public witnesses will be allowed a maximum of four minutes to testify, while Advisory Neighborhood Commissioners will be permitted five minutes to testify. At the discretion of the Chair, the length of time provided for oral testimony may be reduced.

Witnesses who anticipate needing language interpretation, or require sign language interpretation, are requested to inform the Committee of the need as soon as possible but no later than five (5) business days before the proceeding. We will make every effort to fulfill timely requests, however requests received in less than five (5) business days may not be fulfilled and alternatives may be offered.

The Committee also encourages the public to submit written testimony to be included for the public record. Copies of written testimony should be submitted by e-mail to facilities@dccouncil.us. **The record for this public roundtable will close at the close of business on Wednesday, May 4th, 2022.**
