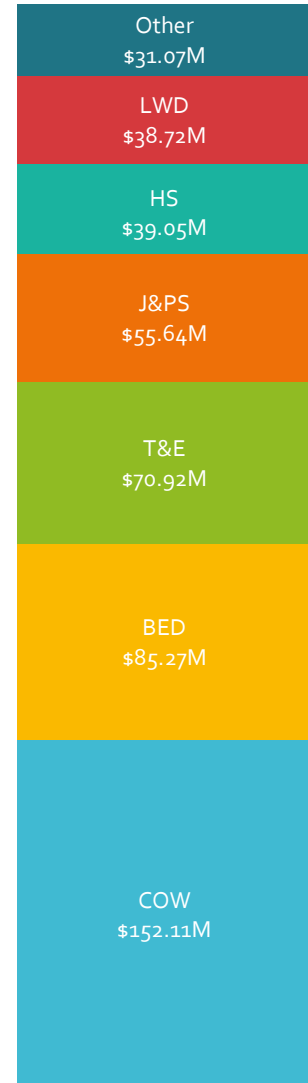

# FY23 ARPA: DCRP – DC Recovery Plan

- Instead of budgeting ARPA federal payment and local revenue replacement directly in each agency's existing budget structure, the EOM placed these funds in a common program called DCRP – DC Recovery Plan
- The DCRP does not provide sufficient transparency on purpose or use for these funds
- The BSA Subtitle, "Reprogramming of American Rescue Plan Act Funds Act" exempts DCRP funds from Council approval requirements for reprogrammings
- The COW recommended striking this subtitle in its committee report
- The Council Budget Office is identifying the correct attributes and will propose the reallocations within each agency's program/activity/service for the COW print

**The Committee approved the Mayor's proposed budget with the following changes to the agencies under its jurisdiction:**

- Reduced \$1.7M (one-time) from OP; \$471k and 4.0 vacant FTEs from DOB; \$244k and 1.0 vacant FTE from ODME; \$182k and 1.0 vacant FTE from DLCP; and carried forward \$120k of local operating funds from FY22 into FY23 to fund the following:
  - \$185k to **SBOE** to fund 2.0 new FTEs (1 position focused on State curricular standards and 1 position in the OSA)
  - \$300k (one-time) to **OP** to enhance the DC History grant program
  - \$500k (one-time) to **Non-Departmental** to increase the District's UDC Fundraising match cap to \$2.0M
  - \$674k to **DOB** to fund 8.0 new Housing Code Inspector FTEs
  - \$800k (one-time) to **ODME** to support the implementation of the Master Facilities Plan included in the Comprehensive Plan (L24-20)

  - \$5k to **DPR** for a Water Polo Program at Deanwood Recreation Center in Ward 7
  - \$70k (one-time) to **DPR** for a contract to a CBO to cover membership fees and transportation services for 50 seniors to therapeutic pools
  - 132k to **DYRS** for 1 FTE (Community Liaison) and IT Support

**The committee approved the Mayor's proposed budget with the following changes to the agencies under its jurisdiction:**

- Allocated \$57M of ARPA funding proposed for the WIC and DOES by program, reduced recurring budget by \$27M, and swept \$3.5M of special fund balance to fund the following:
  - \$7.4M (one-time) to **UPL** to provide expanded benefits for Universal Paid Leave starting July 1, 2022, to be paid retroactively after October 1, 2022
  - \$472k to **DCHR** to administer and implement 2 weeks of paid medical leave for DC Government employees
  - \$18.3M to the **WIC** for:
    - \$980k for UDC faculty to support career pathways in home care and nursing
    - \$2.4M for home health and certified nurse aid training, including \$1.3M for healthcare training grants and \$750k for UDC
    - \$3.7M for IT training, including \$2.7M for IT training grants and \$556k to UDC
    - \$4.6M for Career Coaches
    - \$6.6M for Employer Partnership

  - \$38.6M to **DOES** for:
    - \$2M and 4 FTEs to provide employment to 1,000 students and make the School Year Internship Program permanent
    - \$334k (one-time) and 1 FTE to reserve 100 School Year Internship slots for our most at-risk youth and provide intentional recruitment and support of these youth
    - \$27.1M (one-time) and 40 FTEs to support transitional employment, including \$606k to restore the Jobs First pilot to help returning citizens and homeless residents obtain permanent employment, \$4.5M for Building Blocks, \$23M for Project Empowerment
    - \$5M (one-time) and 11 FTEs to fund the Infrastructure Academy, including \$1M to fund creation of an in-house commercial driver's license training program
    - \$4M (one-time) and 7 FTEs to fund apprenticeship training
    - \$109k (one-time) and 1 FTE for the Year-Round Youth program

# COMMITTEE ON TRANSPORTATION & THE ENVIRONMENT

**The Committee approved the Mayor's proposed budget with the following recommended changes to the agencies under its jurisdiction:**

- Increased revenue by \$4M in FY23 and \$44M over the financial plan:
  - \$599k in FY23 and \$3M over the financial plan by increasing the number of DPW boot crew FTEs
  - \$2.3M in FY23 and \$29.8M over the financial plan by increasing DMV registration fees for heavier vehicles
  - \$1.1M in FY23 and \$11.2M over the financial plan for the DOEE Sustainable Energy Trust Fund by maintaining current assessments on electric and gas usage
- Reduced personnel services budget by \$1.2M by eliminating 5 DPW and 2 DOEE vacant positions and increasing DPW vacancy savings; swept \$3.4M from special purpose fund balances; swept \$1.4M from available capital project balances; and shifted or adjusted capital project allotments to fund the following:

- **Traffic Safety Infrastructure**
  - \$310k for a transportation planner and roadway safety engineer to facilitate improved traffic infrastructure around schools
  - \$18.6M of CIP allotments for planning and implementation of safety infrastructure around schools
  - \$247k and 4 FTEs to **DPW** to increase boot crew coverage and compliance with the District's traffic laws
  - \$734k of CIP allotments to support the creation of a master plan that will facilitate the upgrade of temporary safety projects to permanent, safer, more attractive streetscape features
  - \$250k of CIP allotment for the Crosstown Bike Lanes to fill key gaps in the protected bike lane network
  - \$8.9M of CIP allotments to study, design, and construct a pedestrian and bicycle crossing of the Anacostia Freeway and the CSX railway line on East Capitol Street
  - \$120k to **DDOT** for a survey of available street and private parking in the District

- **Health of District Residents**
  - \$280k to **DOEE** to hire 3 additional Environmental Protection Specialists to undertake mold inspections and remediation
- **Environmental Sustainability**
  - \$4.4M (one-time) to **DPW** to fund a curbside composting pilot at 10,000 District properties
  - \$601k and 6 FTEs to **DPW** for Zero Waste source separation plan review
  - \$105k (one-time) to **DPW** to plan for more recycling infrastructure in the public space
  - \$200k to **DPW** to assist business and nonprofit organizations with acquisition of on-site organic processing systems
  - \$289k to make **DOEE** Solar for All grant awards tax-exempt
  - \$800k for renewable energy storage grants

- **Public Infrastructure & Community Investments**
  - \$50k to **DDOT** to support extending the eligibility of 2020 Visitor Parking Permits through Dec. 31, 2022, and printing of hard copy for Visitor Parking Permits for residents without one
  - \$15M to **DDOT** to accelerate funding for the 11<sup>th</sup> Street Bridge Park
  - \$4M to **DDOT** to fill a gap in the Anacostia Riverwalk and Trail and design of a new waterfront park for Buzzard Point
  - \$736k to **DDOT** for the Dupont Tree Plaza to address stormwater runoff and the heat island effect on Massachusetts Avenue NW
  - \$1.7M to **DDOT** to fund stormwater management infrastructure improvements on Q Street, 27th Street, and Mill Road NW and make repairs to the Lyons Mill Road pedestrian path
  - \$300k to **DMV** for IT upgrade implement a registration fee increase
