Dear Chairman Mendelson:

Pursuant to D.C. Official Code §2-352.02(a), enclosed for consideration and approval by the Council of the District of Columbia is the proposed legislation, "Hi-Tech Solutions, Inc., Contract Approval Resolution of 2022" to approve multi-year contract with Hi-Tech Solutions, Inc. The proposed period of performance is three (3) years from the date of award. The dollar value of the proposed contract for the term is a firm-fixed price of \$23,336.80.

(Hi-Tech) to provide Microsoft software licenses and the accompanying Software Assurance program for the Washington Convention and Sports Authority (the "Authority"). RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Hi-Tech Solutions, Inc. Contract Approval Resolution of 2022" Sec. 2. (a) The Washington Convention and Sports Authority, t/a Events DC, proposes to enter into a multiyear agreement with Hi-Tech for the furnishing of four (4) Microsoft SQL Server 2019 Standard core-based licenses, including the Software Assurance program. (b) This multiyear contract with Hi-Tech is for a firm fixed price of \$23, 336.80 for a term of three (3) years commencing on the date of contract execution. Sec. 3.
