24	RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That
25	this resolution may be cited as the "Modifications to Contract CW57103 with NTT
26	DATA State Health Consulting LLC Approval and Payment Authorization Emergency
27	Declaration Resolution of 2022".
28	Sec. 2. (a) There exists a need for Modification Nos. 18 and 19 to Contract
29	CW57103 with NTT DATA State Health Consulting LLC to provide independent
30	verification and validation (IV&V) services in support of the District's Medicaid
31	Management Information System (MMIS) Core System and to authorize payment for the
32	goods and services received and to be received under the modifications.
33	(b) By Modification No. 18 dated December 6, 2021, the Office of Contracting
34	and Procurement, on behalf of the Department of Health Care Finance, executed a partial

- 1 Option Year 4 to NTT DATA State Health Consulting LLC, for the period from
- 2 December 11, 2021 through March 10, 2022, in the amount of \$698,375.
- 3 (c) Modification No. 19 is now necessary to exercise the remainder of Option
- 4 Year 4 for the period from March 11, 2022 through December 10, 2022 in the amount of
- 5 \$2,097,525, which will increase the total amount for Option Year 4 to \$2,795,900.
- 6 (h) Council approval is required by section 451(b) of the District of Columbia
- 7 Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1–
- 8 204.51(b)) since these modifications increase the contract to more than \$1,000,000 during
- 9 a 12-month period.
- (i) Approval is necessary to allow the continuation of these vital services.
- Without this approval, NTT DATA State Health Consulting LLC cannot be paid for
- goods and services provided in excess of \$1,000,000 for the contract period beginning
- December 11, 2021 through December 10, 2022.
- Sec. 3. The Council of the District of Columbia determines that the
- circumstances enumerated in section 2 constitute emergency circumstances making it
- 16 necessary that the Modifications to Contract No. CW57103 with NTT DATA State

- adopted after a single reading.
