25 To recognize and honor the Sidwell Friends School girls basketball team, 2021/2022
26 DCSAA Class AA girls basketball champions.

27 WHEREAS, Sidwell Friends School is a private high school in northwest Washington,
28 D.C.;

29 WHEREAS, the Sidwell Friends School Quakers compete in the District of Columbia State
30 Athletic Association and the Mid-Atlantic Athletic Conference;

31 WHEREAS, the Quakers, who were undefeated 28-0 overall this season, including 14-0 in
32 league play, advanced to the DCSAA championship game after defeating Maret School in the
33 semi-finals. Sidwell Friends School faced Georgetown Visitation Preparatory School in the
34 championship game;

35 WHEREAS, Sidwell Friends School controlled the game, building up a thirteen-point lead
36 at halftime. The Quakers extended their lead in the third and fourth quarters, winning the DCSAA
37 championship 69 to 41;

38 WHEREAS, Leah Harmon, sophomore forward for Sidwell Friends School, led the team
39 in scoring and scored a game-high 24 points;

WHEREAS, seniors like Kiki Rice, the Naismith High School Player of the Year who compiled 10 points and 10 rebounds in the game, were integral to the success of the Quakers this season;

WHEREAS, the Sidwell Friends School girls basketball team finished the season as the #1 nationally ranked girls basketball team, according to MaxPreps and ESPN;

WHEREAS, Coach Tamika Dudley, the Naismith High School Coach of the Year, led the Quakers to their first-ever DCSAA championship; and

WHEREAS, Sidwell Friends School boys and girls basketball teams each won the DCSAA Class AA championship this season.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, that this resolution may be cited as the “Sidwell Friends School Girls Basketball DCSAA Class AA Championship Recognition Resolution of 2022”.
