The stated purpose of PR24-0686, the “Commission on Human Rights Charlotte Clymer Confirmation Resolution of 2022” is to confirm the appointment of Ms. Charlotte Clymer, a Ward 7 resident, as a member of the Commission on Human Rights, replacing Gunther Sanabria, for a term to end December 31, 2024.

The stated purpose of PR24-0687, the “Commission on Human Rights Eleanor Collinson Confirmation Resolution of 2022” is to confirm the reappointment of Ms. Eleanor Collinson, a

Ward 3 resident, as a member of the Commission on Human Rights, for a term to end December 31, 2024.

The stated purpose of PR24-0688, the “Commission on Human Rights Robert Baldwin, III Confirmation Resolution of 2022” is to confirm the appointment of Mr. Robert Baldwin, III, a Ward 6 resident, as a member of the Commission on Human Rights, replacing Dr. John D. Robinson, for a term to end December 31, 2024.

The stated purpose of PR24-0689, the “Commission on Human Rights Stuart Anderson Confirmation Resolution of 2022” is to confirm the appointment of Mr. Stuart Anderson, a Ward 8 resident, as a member of the Commission on Human Rights, replacing Mark Herzog, for a term to end December 31, 2024.

The Committee invites the public to testify remotely or to submit written testimony. Anyone wishing to testify must sign up at https://docs.google.com/forms/d/e/1FAIpQLSeA5DFJ5bYIIKU-fMe_70uVdtXBys7KrO1r5KKXInKO2SuppQ/viewform. or by phone at (202) 741-8593, and provide their name, phone number or e-mail, organizational affiliation, and title (if any) by **the close of business on Tuesday, June 28, 2022**. Witnesses are encouraged, but not required, to submit their testimony in writing electronically in advance to facilities@dccouncil.us. Witnesses will participate remotely via Zoom. The Committee will follow-up with witnesses with additional instructions on how to provide testimony in advance of the proceeding.

All public witnesses will be allowed a maximum of four minutes to testify, while Advisory Neighborhood Commissioners will be permitted five minutes to testify. At the discretion of the Chair, the length of time provided for oral testimony may be reduced.

Witnesses who anticipate needing language interpretation, or require sign language interpretation, are requested to inform the Committee of the need as soon as possible but no later than five (5) business days before the proceeding. We will make every effort to fulfill timely requests, however requests received in less than five (5) business days may not be fulfilled and alternatives may be offered.

The Committee also encourages the public to submit written testimony to be included for the public record. Copies of written testimony should be submitted by e-mail to facilities@dccouncil.us. **The record for this public roundtable will close at the close of business on Friday, July 1, 2022.**
