21 To amend, on an emergency basis, An Act Making appropriations to provide for the expenses of  
22 the government of the District of Columbia for the fiscal year ending June thirtieth,  
23 nineteen hundred and fourteen and for other purposes to set qualifications for the first  
24 member of the Public Service Commission nominated after July 1, 2022.

26 BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this  
27 act may be cited as the “Public Service Commission Member Qualifications Emergency  
28 Amendment Act of 2022”.

29 Sec. 2. Paragraph 97(a) of Section 8 of An Act Making appropriations to provide for the  
30 expenses of the government of the District of Columbia for the fiscal year ending June thirtieth,  
31 nineteen hundred and fourteen and for other purposes, approved March 4, 1913 (37 Stat. 995;  
32 D.C. Official Code § 34-801), is amended by striking the phrase “1978.” and inserting the phrase  
33 “1978. The first member nominated after July 1, 2022, shall have substantive expertise in electric  
34 grid modernization, renewable energy integration or technology, and, where possible, issues

35 impacting the environment; provided, that this requirement shall not apply to the renomination of  
36 a member serving on the Commission as of July 1, 2022.” in its place.

37           Sec. 3. The Public Service Commission Member Qualifications Temporary Amendment  
38 Act of 2021, effective February 18, 2022 (D.C. Law 24-64; 68 DCR 13507), is repealed.

39           Sec. 4. Applicability.

40           This act shall apply as of July 1, 2022.

41           Sec. 5. Fiscal impact statement.

42           The Council adopts the fiscal impact statement of the Budget Director as the fiscal impact  
43 statement required by section 4a of the General Legislative Procedures Act of 1975, approved  
44 October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).

45           Sec. 6. Effective date.

46           This act shall take effect following approval by the Mayor (or in the event of veto by the  
47 Mayor, action by the Council to override the veto), and shall remain in effect for no longer than  
48 90 days, as provided for emergency acts of the Council of the District of Columbia in section  
49 412(a) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 788;  
50 D.C. Official Code § 1-204.12(a)).
