22	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
23	act may be cited as the "2662 Martin Luther King, Jr. Avenue, Southeast Tax Sale Certificate
24	Congressional Review Emergency Amendment Act of 2022".
25	Sec. 2. Section 47-1382 of the District of Columbia Official Code is amended by adding
26	a new subsection (f-1) to read as follows:
27	"(f-1)(1) Notwithstanding subsection (f) of this section, the validity of a certificate of sale
28	or judgement issued with respect to the tax sale of the property located at 2662 Martin Luther
29	King, Jr. Avenue, S.E., known for tax and assessment purposes as Lot 1034 in Square 5868,
30	("property") shall be extended in accordance with the requirements of this subsection.
31	"(2) Within 30 days after the effective date of this subsection, the Mayor shall
32	issue a tax deed bill for the property.

33	"(3) A tax sale purchaser, or the purchaser's assignee, shall have 180 days
34	following the issuance of the tax deed bill, as required by paragraph (2) of this subsection, to pay
35	the tax deed bill.
36	"(4) Within 30 days after a timely payment of the tax deed bill by the purchaser,
37	or assignee, the Mayor shall issue the tax deed.".
38	Sec. 3. Applicability.
39	This act shall apply as of April 30, 2020.
