On Friday, November 4, 2022, Councilmember Robert C. White Jr., Chair of the Committee on Government Operations and Facilities, will hold a public hearing on B24-0999, the "Revised Project Labor Agreement Cost Threshold Amendment Act of 2022". The stated purpose of B24-0999, the "Revised Project Labor Agreement Cost Threshold Amendment Act of 2022" is to amend the Procedural Practices Reform Act of 2010 to revise the cost threshold for the required use of project labor agreements on construction contracts from \$75 million to \$50 million.

Witnesses are encouraged, but not required, to submit their testimony in writing electronically in advance to facilities@dccouncil.us. Witnesses will participate remotely via Zoom. The Committee will follow-up with witnesses with additional instructions on how to provide testimony in advance of the proceeding.

All public witnesses will be allowed a maximum of four minutes to testify, while Advisory Neighborhood Commissioners will be permitted five minutes to testify. At the discretion of the Chair, the length of time provided for oral testimony may be reduced.

Witnesses who anticipate needing language interpretation, or require sign language interpretation, are requested to inform the Committee of the need as soon as possible but no later than five (5) business days before the proceeding. We will make every effort to fulfill timely requests, however requests received in less than five (5) business days may not be fulfilled and alternatives may be offered.

The Committee also encourages the public to submit written testimony to be included for the public record. Copies of written testimony should be submitted by e-mail to facilities@dccouncil.us. The record for this public hearing will close at the close of business on Friday, November 11<sup>th</sup>, 2022.
