Councilmember Elissa Silverman, Chair of the Committee on Labor and Workforce Development, announces a public roundtable on PR24-991, “Compensation and Working Conditions Agreement between the District of Columbia Public Schools and the Council of School Officers, Local #4, American Federation of School Administrators, AFL-CIO Approval Resolution of 2022” and PR24-992, “Compensation and Working Conditions Agreement between the District of Columbia Government and the Federation of Administrative Law Judges – D.C. Approval Resolution of 2022.” The roundtable will be held virtually at 10:30 a.m. on Thursday, November 3, 2022.

PR24-991 considers the collective bargaining agreement (CBA) which covers compensation matters between the District and public school administrators from October 1, 2020, until September 30, 2024. PR24-992 considers the CBA which covers compensation matters between the District and the Administrative Law Judges at OAH from October 1, 2020, until September 30, 2023. The Council’s authority to review these CBAs is pursuant to D.C. Official Code §1-617.15(a). The CBAs will deem approved on November 11, 2022.

Witnesses may use their phone or computer to participate in this virtual roundtable. Those who wish to testify live before the Committee must sign up no later than 5:00pm on, Tuesday, Nov. 1, 2022, by providing their information using the following link: <https://forms.gle/gRBjdCSooeaw5gds9>. Witnesses must provide their name, email, telephone number, organizational affiliation (if any), and job title (if any), as well as whether they require language interpretation or sign language interpretation.

Witnesses who require language interpretation or sign language interpretation are asked to complete the form linked above or email the Labor Committee at labor@dccouncil.gov as soon as possible, and if possible by Monday, October 24, 2022. The Council’s Office of the Secretary will

fulfill timely requests for language interpretation services; however, some requests may not be fulfilled due to vendor availability.

On Wednesday, November 2, 2022, the Committee will email witnesses who signed up by Tuesday, November 1, 2022, in order to provide them with details about how to participate in the roundtable via the Zoom platform. Only witnesses who have signed up by the November 1, 2022, 5:00 pm deadline will be permitted to participate. Those planning to testify are encouraged to submit an electronic copy of written testimony by 12:00 p.m. on Wednesday, November 2, 2022, so that staff may distribute testimonies to Committee members and staff before the roundtable. Those individuals representing organizations will have five minutes to present their testimony, and other individuals will have three minutes to present their testimony; less time will be allowed if there are a large number of witnesses.

If a witness is unable to testify live at the roundtable, written statements are encouraged and will be made a part of the official record. Written statements should be submitted by email labor@dccouncil.gov. Additionally, the public may provide testimony by voice mail by calling (202) 455-0153, stating and spelling the witness's name, stating any organizational affiliation, and speaking slowly to provide a statement to be transcribed and included in the record. The record will close at 5:00 p.m. on Thursday, November 10, 2022.
