26	Sec. 2. (a) In 2019, the District of Columbia Housing Authority ("DCHA") participated
27	in a request for proposals issued by the District of Columbia Department of Housing and
28	Community Development. Of the multiple proposals received, 34 developers were chosen to
29	work with DCHA and other District agencies to develop affordable housing and permanent
30	supportive housing units for extremely low-income families making zero to 30% of the area's
31	median income, as well as the chronically homeless and individuals with mental or physical
32	disabilities. Upon approval of the contract by the Council, DCHA will enter into an agreement to
33	enter into a long-term subsidy contract ("ALTSC") with the selected housing providers under the
34	Local Rent Supplement Program ("LRSP") for housing services.
