A RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve Contract No. NFPHC-HL-23-C between the Not-for-Profit Hospital Corporation, commonly known as United Medical Center (“Hospital”), and George Washington University Medical Faculty Associates, Inc., (“GW MFA”), for the provision Inpatient Hospitalists Services to the Hospital, and to authorize payment for the services received and to be received under the Contract.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the “Contract No. NFPHC-HL-23-C between the Not-for-Profit Hospital Corporation and George Washington University Medical Faculty Associates, Inc., (“GW MFA”), Approval and Payment Authorization Emergency Declaration Resolution of 2022”.

Sec. 2. (a) There exists an immediate need to approve Contract No. NFPHC-HL-23-C (“Contract”) between the Not-for-Profit Hospital Corporation (“Hospital”) and George Washington University Medical Faculty Associates, Inc., (“GW MFA”), for the provision Inpatient Hospitalists Services to the Hospital, and to authorize payment for the services received and to be received under this Contract.

37 (b) To avoid a disruption in critical patient care services while the parties
38 negotiated a new post-pandemic contract, the parties entered into a one month letter
39 contract with a value of \$538,075.58 for the period of October 1, 2022 to October 31,
40 2022. Council approval was not required.

41 (c) With negotiations successfully completed, the parties hereby submit the
42 definitized version of the base year of the Contract in the amount of \$6,018,096.73, with
43 a retroactive period of October 1, 2022 to September 30, 2023, because when combined,
44 the aggregate value exceeds \$1million in a 12-month period; therefore, Council approval
45 is necessary.

46 (h) Without this approval, George Washington University Medical Faculty
47 Associates, Inc., (“GW MFA”),.. cannot be paid for these critical services provided and
48 to be provided in excess of \$999,999.99.

49 Sec. 3. The Council determines that the circumstances enumerated in section 2
50 constitute emergency circumstances making it necessary that Contract No. NFPHC-HL-
51 23-C between the Not-for-Profit Hospital Corporation and George Washington
52 University Medical Faculty Associates, Inc., (“GW MFA”),.. Approval and Payment
53 Authorization Emergency Act of 2022, be adopted after a single reading.

54 Sec. 4. This resolution shall take effect immediately.
