RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, that this resolution may be cited as "Modification Nos. M02, M03, and M04 to Contract No. DCAM-20-NC-RFP-0013-A6 with The Decca Development Corporation Approval and Payment Authorization Emergency Declaration Resolution of 2022". Sec. 2 (a) There exists an immediate need to approve Modification Nos. M02, M03, and M04 to the Contract for on-call facility maintenance and repair services (Contract No. DCAM-20-NC-RFP-0013-A6) (the "Contract"), between the Department of General Services (the "Department") and The Decca Development Corporation (the "Contractor"), to increase the aggregate not-to-exceed ("NTE") amount of Option Year Two to \$14,000,000, and to authorize payment to the Contractor for services received and to be received under the modifications. (b) On June 24, 2022, via Modification No. M02, the Department partially exercised Option Year Two of the Contract, extending the term of the Contract from June 26, 2022, through Department executed Modification No. M03 and partially exercised another fraction of Option
Year Two extending the term of the Contract for Option Year Two through December 31, 2022;
and did not alter the NTE amount for Option Year Two. The aggregate NTE amount of

- 42 (c) Proposed Modification No. M04 would exercise the remainder of Option Year Two, 43 extending the term of the Contract through June 25, 2023, and increase the aggregate NTE amount 44 of Option Year Two by \$13,050,000, from \$950,000 to \$14,000,000. Modification Nos. M02, M03 45 and proposed Modification No. M04 will fully exercise Option Year Two and increase the total 46 NTE amount of Option Year Two of the Contract by an amount in excess of \$1 million; thus, 47 Council approval of the proposed contract action is required pursuant to section 451 of the District 48 of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-49 204.51), and notwithstanding section 202 of the Procurement Practices Reform Act of 2010, 50 effective April 8, 2011 (D.C. Law 18-371; D.C. Official Code § 2-352.02).

M02, M03, and M04 to Contract No. DCAM-20-NC-RFP-0013-A6 with The Decca Development Corporation Approval and Payment Authorization Emergency Act of 2022" be adopted after a single reading.
