

OMA COMPLAINT ADJUDICATION

A complaint regarding possible violations of the Open Meetings Act (OMA) is made and received by the Office of Open Government (OOG). This may be by in person, mail, or electronic mail. Upon receipt, the Director acknowledges and timely reviews and investigates the complaint, requesting all necessary information to determine the OOG's best course of action, considering a multitude of factors.

Alternatively, the Director may issue an advisory opinion ("A.O.") on OMA compliance on their own initiative ("sua sponte"), or at the request of a public official or public employee. Only sua sponte advisory opinions or advisory opinions requested by an employee or pubic official may be appealed. The aggrieved person must appeal in writing to the Board of Ethics and Government Accountability (BEGA) for consideration within ten (10) business days of the issuance of the A.O.; otherwise, it is final and not appealable. The Director may file a response within ten (10) business days of receiving a copy of the appeal. The Board shall issue a written decision on the appeal as soon as practicable. Until or unless the Board disapproves in writing, the A.O. is binding. If the Board does not issue a decision on the appeal within six months of receipt, the A.O. is deemed approved. The Board's decision is final and not subject to further appeal.

The Director may: request additional information from the complainant or public body; dismiss the complaint; conciliate the complaint; or initiate issuing an A.O.

If conciliation is specified, and a resolution of the dispute is not achieved through discussion and exchange of views, then the Director may: dismiss the complaint; investigate further; issue an A.O.; or take any other step permitted by the OMA, and in the D.C. Code and DCMR.

Dismissal may be based upon on one or more factors: complaint does not raise issues within the Director's authority under the OMA; action complained of does not violate the OMA; complainant declined to provide information or failed to respond within thirty (30) days to such a request; failure to cooperate with the investigation; a technical violation committed that constitutes a harmless error that does not infringe upon the Complainant's rights under the OMA; or complaint becomes moot due to action taken by the public body.

If further investigation or an A.O. are pursued, the public body will be allowed to address the complaint's allegations, and all parties may be asked for further information. If the corrective actions set forth in an A.O. are not taken or not completed in a timely matter, or it is determined after investigation that a Public Body has or intends to violate the provisions of the OMA, the Director may bring suit in the Superior Court of the District of Columbia for injunctive or declarative relief, without first issuing an A.O.

If an A.O. is issued, the Director shall provide copies directly to the complainant; the public body; and to the public, by posting it on its website, https://www.open-dc.gov/. The OOG has plans to publish A.O.s in the *District of Columbia Register*.
