

## A BILL

## IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To authorize, on an emergency basis, the Deputy Mayor for Planning and Economic 1 2 Development to issue a grant is Fiscal Year 2023 or 2024 to support renovations to the 3 Ben's Chili Bowl U Street Location, and to issue a grant is Fiscal Year 2023 or 2024 to 4 the African American Civil War Memorial Freedom Foundation, Inc. for the purpose of 5 redeveloping the African American Civil War Museum. 6 BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this 7 act may be cited as the "African American Civil War Museum and Ben's Chili Bowl Limited 8 9 Grant-Making Authority Emergency Amendment Act of 2023". 10 Sec. 2. Section 2032 of the Deputy Mayor for Planning and Economic Development 11 Limited Grant-Making Authority Act of 2012, effective September 20, 2012 (D.C. Law 19-168; 12 D.C. Code § 1-328.04), is amended by adding new subsections (ee) and (ff) to read as follows: 13 14 "(ee) Notwithstanding the Grant administration Act of 2013, effective December 24, 2013 (D.C. Law 20-61; D.C. Official Code § 1-328.11 et seq.), the Deputy Mayor may make a 15 16 grant in Fiscal Year 2023 or 2024 to support renovations to the Ben's Chili Bowl U Street N.W. 17 location.. 18 "(ff) Notwithstanding the Grant administration Act of 2013, effective December 24, 2013 19 (D.C. Law 20-61; D.C. Official Code § 1-328.11 et seq.), the Deputy Mayor may make a grant in

- Anacostia Waterfront Corporation Reorganization Act of 2008, effective March 26, 2008 (D.C.
- Law 17-138; D.C. Official Code § 2-1225.21), is amended by adding a new subsection (d-3) to
- read as follows:
- 27 "(d-3) Moneys credited to the Account may be used to provide grants authorized by
- sections 2032(ee) and (ff) of the Deputy Mayor for Planning and Economic Development
- 29 Limited Grant-Making Authority Act of 2012, effective September 20, 2012 (D.C. Law 19-168;
- 30 D.C. Official Code § 1-328.04(ee) and (ff)).".

- This act shall take effect following approval by the Mayor (or in the event of veto by the
- Mayor, action by the Council to override the veto), and shall remain in effect for no longer than
- 38 90 days, as provided for emergency acts of the Council of the District of Columbia in section
- 39 412(a) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 788;
- 40 D.C. Official Code § 1-204.12(a)).
