A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve Modification Nos. 7 and 8 to Contract No. CW97545 with Dynamic Systems, Inc. to provide Oracle Software licenses to the Department of Health Care Finance and to authorize payment for the goods and services received and to be received under the modifications.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the “Modifications to Contract No. CW97545 with Dynamic Systems, Inc. Approval and Payment Authorization Emergency Declaration Resolution of 2023”.

Sec. 2. (a) There exists a need to approve Modification Nos. 7 and 8 to Contract No. CW97545 with Dynamic Systems, Inc. to provide Oracle Software licenses to the Department of Health Care Finance and to authorize payment for the goods and services received and to be received under Modification Nos. 7 and 8.

(b) By Modification No. 7, dated December 26, 2022, the Office of Contracting and Procurement, on behalf of the Department of Health Care Finance, partially exercised option period 1 of Contract No. CW97545 with Dynamic Systems, Inc. for the period

34 from December 29, 2022 through April 28, 2023 in the not-to-exceed amount of
35 \$597,698.15.

36 (c) Modification No. 8 is now necessary to exercise the remainder of option
37 period 1 for the period from April 29, 2023 through December 28, 2023 in not-to-exceed
38 of \$836,777.41, which will increase the total not-to-exceed amount for option period 1 to
39 \$1,434,475.56.

40 (d) Council approval is required by section 451(b) of the District of Columbia
41 Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-
42 204.51(b)) since these modifications increase the contract to more than \$1 million during
43 a 12-month period.

44 (e) Approval is necessary to allow the continuation of these vital services.
45 Without this approval, Dynamic Systems, Inc. cannot be paid for goods and services
46 provided in excess of \$1 million for the contract period beginning December 29, 2022
47 through December 28, 2023.

48 Sec. 3. The Council of the District of Columbia determines that the
49 circumstances enumerated in section 2 constitute emergency circumstances making it
50 necessary that the Modifications to Contract No. CW97545 with Dynamic Systems, Inc.
51 Approval and Payment Authorization Emergency Act of 2023 be adopted after a single
52 reading.

53 Sec. 4. This resolution shall take effect immediately.
