

### The Committee approved the Mayor's proposed operating budget with the following changes to the agencies under its jurisdiction:

- Transferred out \$136M from PayGo across the plan, \$3.0M (one-time) from Non-Departmental, \$871k from OSSE, \$151k (one-time) from ODCA; made technical reductions of \$4.4M (\$995k one-time) to OSSE to align with Mayor's BSA Sec. 7028 and \$3.6M (one-time) to OPEB-A; made technical increase of \$417k to UDC; reallocated \$51.3M (\$29.7M one-time) within DCPS; reallocated \$5.1M within CAH; and received \$3.0M of operating transfers to fund the following:
  - \$35.8M in and to **DCPS**:
    - \$28.9M to fully fund the Schools First in Budgeting Amendment Act of 2021 (L24-300)
