A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve Modification Nos. 3 and 4 to Contract No. CW93294 with IMA Professional Services of DC, PC to conduct medical record reviews and consultative exams for claimants that are either currently receiving Social Security Supplemental Security Income or applying for a disability determination with the Social Security Administration, and to authorize payment for the goods and services received and to be received under the modifications.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the “Modifications to Contract No. CW93294 with IMA Professional Services of DC, PC Approval and Payment Authorization Emergency Declaration Resolution of 2023”.

Sec. 2. (a) There exists a need to approve Modification Nos. 3 and 4 to Contract No. CW93294 with IMA Professional Services of DC, PC to conduct medical record reviews and consultative exams for claimants that are either currently receiving Social Security Supplemental Security Income or applying for a disability determination with the Social Security Administration, and to authorize payment for the goods and services received and to be received under the modifications.

35 (b) By Modification No. 3, dated February 28, 2023, the Office of Contracting
36 and Procurement, on behalf of the Department on Disability Services, exercised a partial
37 option of option year 1 of Contract No. CW93294 with IMA Professional Services of
38 DC, PC for the period from March 1, 2023 through April 30, 2023 in the not-to-exceed
39 amount of \$999,999.00.

40 (c) Modification No. 4 is now necessary to exercise the remainder of option year
41 1 of Contract No. Contract No. CW93294 with IMA Professional Services of DC, PC in
42 the not-to-exceed amount of \$3,235,649.90, bringing the total not-to-exceed amount for
43 the period from March 1, 2023 through February 29, 2024 to \$4,235,648.90.

44 (d) Council approval is required by section 451(b) of the District of Columbia
45 Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-
46 204.51(b)) since these modifications will increase the value of the contract to more than
47 \$1 million during a 12-month period.

48 (e) Approval is necessary to allow the continuation of these vital services.
49 Without this approval, IMA Professional Services of DC, PC cannot be paid for goods
50 and services provided in excess of \$1 million for the contract period March 1, 2023
51 through February 29, 2024.

52 Sec. 3. The Council of the District of Columbia determines that the
53 circumstances enumerated in section 2 constitute emergency circumstances making it
54 necessary that the Modifications to Contract No. CW93294 with IMA Professional
55 Services of DC, PC Approval and Payment Authorization Emergency Act of 2023 be
56 adopted after a single reading.

57 Sec. 4. This resolution shall take effect immediately.
