The stated purpose of Bill 25-171 is to symbolically designate the 1900 block of Gallaudet Street, N.W. as “Alexander Crummell Way.” The stated purpose of Bill 25-172 is to symbolically designate Randolph Street, N.E. between 19th Street, N.E. and 24th Street, N.E. as “William R. Spaulding Way.” The stated purpose of Bill 25-173 is to symbolically designate the 1200 block of Kearney Street, N.E. as “Sterling A. Brown Way.” The stated purpose of Bill 25-174 is to

symbolically designate the 100 block of N Street, N.W. as “Rayford Logan Way.” The stated purpose of Bill 25-175 is to symbolically designate the 800 block of 26th Street, N.E. as “John Mercer Langston Way.” The stated purpose of Bill 25-176 is to symbolically designate the 1400 block of Morse Street, N.E. as “Edna Brown Coleman Way.” The stated purpose of Bill 25-177 is to symbolically designate Queens Chapel Terrace Road, N.E. between Crittenden Street, N.E. and Michigan Avenue, N.E. as “Julius Hobson Sr. Way.” The stated purpose of Bill 25-178 is to symbolically designate 1800 block of 2nd Street, N.W. as “Dorothy Celeste Boulding Ferebee Way.” The stated purpose of Bill 25-193 is to symbolically designate G Street, N.W., between 19th Street and 22nd Street, N.W. as “Jeanette A. Michael Way.” The stated purpose of Bill 25-235 is to *officially* designate the public alley system within Square 3015, bounded by Georgia Avenue, N.W., Crittenden Street, N.W., 9th Street, N.W., and Buchannan Street, N.W. as “Catlett Alley.” The stated purpose of Bill 25-246 is to *officially* designate the public space abutting Square 2596, Lot 1057, at the northwest corner of Mount Pleasant Street, N.W., and Kenyon Street, N.W. as “Amigos Park.” The stated purpose of Bill 25-316 is to symbolically designate the public alley system within Square 242 bounded by 14th Street, Rhode Island Avenue, Logan Circle, Vermont Avenue, and N Street, N.W. as “Gordon Way.” An official designation of an alley enables the placement of addresses and possible development.

Those who wish to testify must register using the Council’s Hearing Management System at <https://lims.dccouncil.gov/hearings> by **5:00 p.m. on Tuesday, July 11, 2023. Testimony is limited to four minutes.** Witnesses who anticipate needing spoken language interpretation, or require sign language interpretation, are requested to inform the Committee office of the need as soon as possible but no later than five business days before the proceeding by emailing cow@dccouncil.gov. We will make every effort to fulfill timely requests, although alternatives may be offered. Requests received in less than five business days may not be fulfilled. Witnesses will receive instructions on how to participate by Zoom prior to the hearing. Public witnesses will participate virtually via the Internet on the Zoom Video Conference platform. Testimony should be submitted through the Council’s Hearing Management System (<https://lims.dccouncil.gov/hearings>) in advance of the hearing. Testimony will be publicly accessible upon Committee review. If you are unable to testify at the hearing, written statements are encouraged and will be made a part of the official record. Statements for the record should be submitted through the Hearing Management System or left by voicemail by calling (202) 430-6948 (up to 3 minutes which will be transcribed). The record will close at 5:00 pm on Thursday, July 27, 2023.
