Owners of properties, known as nuisance properties, that are in violation of DOB codes or regulations, are assessed a fee for cost the District incurs in cleaning up the property: Vacant Property Registration; Proactive Inspection Fees; Rental Accommodation Fees.

Description of Program:

Coordinates and monitors enforcement of violations cited by the agency’s regulatory programs; registers vacant properties to encourage their return to productive use; and abates nuisances on properties throughout the District.

Purpose of Expenditures:

63 FTE's - salaries, benefits and overtime; Supplies for abatement; abatement contractors; proactive inspection contractors; and abatement equipment.

Because of the public health emergency, there was a significant decrease in revenue collection for some of the Special Purpose Revenue (SPR) funds in FY2021, and we had to cut back in spending and slow hiring which resulted in both Personnel Services (PS) and Non-Personnel Services (NPS) budget surpluses. The breakdown of these surpluses is as follows:

\$79,277.57 surplus in Local Fund - vacancy savings (\$16K) and lower than anticipated Non-Personnel Services costs for supplies (\$23K), and equipment (\$60K).

Measures taken as a result of lower revenues due to the pandemic. To offset low revenues, hiring was slowed and resulted in a PS budget surplus of \$1,362,001.21.

The remaining \$2,598,357.25 is NPS budget surplus. A reprogramming of \$2.4M was processed to transfer Local Fund from other Agencies to DCRA in order to cover SPR revenue shortfalls.

In addition, the Agency used Local Funding for some of the SPR activities to help address the revenue shortfall.

The \$1,243,059.42 surplus in Local Fund is mainly due to vacancy savings (\$115K) and lower spending in contractual services (\$986k) as a result of delays in the contracting process. Most of these contracts are related to Information Technology.

Other reasons for the surplus in Local Fund include lower than anticipated Non-Personnel Services costs for supplies (\$74K), and equipment (\$63K).

The \$4,624,891.23 surplus in Special Purpose Revenue Funds is due to vacancy savings (\$2.4M) and delay of the Corporations Registration System replacement contract (\$1M).

In addition, there were lower spending in Non-Personnel Services including supplies (\$354K), equipment (\$438K), telecommunications (\$116), and professional services (\$236k)

Question 23

(a) What efforts has your agency made in the past year to increase transparency? Explain.

Response: In the past year, the Department of Buildings, formerly the Department of Consumer and Regulatory Affairs, continued its five-year strategic plan (<https://www.dcrfutureready.com/>) as a foundation to build on our expressed policy of transparency. As the plan notes, “DCRA will continue to operate in an open, accessible way. The agency will utilize and adapt the ‘dashboard’ mentality into every facet of its work. The same data that is used to inform decision making and process improvement is the same data to which the public will have continuous access. That level of transparency is a key to holding the agency accountable for meeting its mission and its high standards for performance.”

There are several projects that the agency has worked on during FY22 to further improve transparency:

1. **Tertius:** Tertius is a new third-party inspection marketplace. Tertius easily connects customers with qualified inspectors at their convenience and within their budget. This platform was created to present more convenient options for customers, and to potentially shorten the timeline to complete inspections. Tertius brings a supply of customers directly to each inspector and provides a platform to conduct and report inspection activity – streamlining and speeding up the process. This platform will also allow independent and smaller inspection agencies to compete with larger inspections agencies.
2. **Pre-Approved Plans Platform:** The Pre-Approved Plans Platform allows customers to choose from a selection of plans that are pre-approved for code compliance by DOB. In order to properly assess zoning requirements, DOB created a checklist for use by design professionals enabling customers to dramatically shorten the customer timeline. Customers can choose from a library of plans, connect with a design professional, and begin expedited plan review. The Pre-Approved Plans Platform make it easy to get support needed to complete projects and stay on budget.

(b) What efforts will your agency be making to increase transparency in fiscal year 2023? Explain.

DOB is continuing its goal of being at the forefront of agency transparency by unveiling a revamped Agency Public Dashboard (rebranded from the Agency Performance Dashboard). This new dashboard offers a critical, real-time snapshot into agency operations. The dashboard includes following sections:

- Agency Performance – measuring operational effectiveness and efficiency by keeping track of DOB’s Key Performance Indicators and Organizational Metrics.
- Permit Operations – providing insight into permit operations, by visualizing data on permit application and issuance.
- Inspections – displaying data that offers information on the safety and compliance inspections on construction projects, residential dwellings, and vacant properties.
- Violations and Abatement – offering tools that allow interested parties to search on housing code and property maintenance violations and their statuses.
- Enforcement – proving information on Notices of Infraction (NOIs) to ensure compliance with building, housing and construction codes, and licensing regulations.
- Vacant Properties – providing and accurate and accessible look into vacant properties and lots, and their statuses.
- DOB Index – a new section of the dashboard, offers data into the economic health of the District through a lens of construction activity.

What are your top five priorities for the agency? Please provide a detailed explanation for how the agency expects to achieve or work toward these priorities in fiscal years 2023 and 2024.

Response:

1. Attract and retain talented staff, support and empower staff with the right motivation, information, equipment, training, policies, procedures, systems, and regular opportunities for dialogue and feedback as we shepherd transformation together. Some of the ways to achieve or work toward our staffing priority includes:

- DOB will create a Career Pathways program designed to provide recent Architecture and Engineering graduates with support and career experience. Recruits will rotate between all DOB departments to have a wide array of exposure in learning permit intake, inspections, plan review, enforcement, and customer service. The goal is to create a pipeline of talent to mitigate staff and field shortages.
- DOB will plan, develop, and execute a Training Academy platform that will be the central training repository for all trainings for DOB staff and Resident Inspectors. This includes the ability to see all courses and quizzes resident inspectors must take to meet required learning outcomes. This will also allow DOB staff to create trainings, evaluations and other tools to ensure staff have the most up to date techniques for interacting with internal and external customers.

2. Explore, pilot, and implement technological innovations to improve the efficiency and effectiveness of services delivered to residents and business owners.

- DOB will pilot an artificial intelligence (AI) powered building permit approval using building information modeling (BIM) files for permitting construction projects that require plan reviews. Instead of pdf files, architects and engineers may submit design and construction documents in non-proprietary and standard BIM file format. The BIM format will ensure that the plans for review contain rich data such as code ventilation calculations for mechanical studies and automatically checked for compliance with an algorithm to save time and effort in the review process.
- DOB will leverage platform technology to streamline the Certificate of Occupancy (C of O) process, by creating a pre-application checklist that will by ensure applicants meet all prerequisite requirements to ensure a complete application. DOB will accomplish this by automating the status notifications of the review process for business units and applicants. This automation will improve the audit trail for legitimate C of O issuance and ensure higher quality C of O review, without slowing down the process.
- DOB will deploy a new data system for managing vacant buildings, enhance the enforcement and data collection related to vacant properties by establishing a portal(s) that will assist property

owners by accomplishing the following: 1) notify property owners of their most current occupancy status with the Office of Tax and Revenue (OTR), to include last notification date; 2) notify property owners of their most current registration/exemption status to include end date.

3. Support economic development through permit review service level agreements, partnerships, and enhancing online tools for self-service.

- DOB will work on expanding the self-service features of residential Permit Wizard to commercial projects.
- DOB will launch a dashboard to provide transparency into average permit review times by permit type to not only provide expected approval times but also provide of level of predictability to developers, contractors, owners, and stakeholders.

4. Expand protections available to homeowners from construction damage and enhance rental housing safety:

- DOB will enhance protections in place by creating regulations to implement the Adjacent and Adjoining Property Protection Act and expanding the providers on the DOB Insurance Education Center.
- DOB will focus on the abatement of life safety housing violation with incentives for abatement of code violations, disincentives for repeat offenders, publishing data, and increasing awareness about the Department's role in enforcing compliance. DOB has implemented, and continues to develop, a system that identifies violations that are a danger to the life, health, and safety of residents. These "life-safety" violations are subject to special emergency infraction notices and accelerated abatement timelines.

5. Increase awareness of the newly created Department of Buildings

DOB will launch a coordinated outreach campaign that will actively engage communities across the District about DOB processes and procedures. These include workshops in communities, educational sessions, online videos posted, and online and in-person training sessions.

Question 31

Please describe what quality control processes (e.g., periodic audits of files, etc.) in place to ensure notices of infraction and supporting documentation contains the appropriate information and level of detail. Additionally, please describe any corrective actions taken if it is determined that the notice of infraction or supporting documentation is incomplete or insufficient.

Response:

All Notices of Infraction (NOIs) are subject to the following quality controls:

1. Before being filed with the Office of Administrative Hearings (OAH) all NOIs are reviewed by Civil Infractions for completeness and accuracy. Civil Infractions may mark an NOI as “defective” and send it back to the program area for correction of the particular defects identified.
2. After any NOI is generated or compiled it is also subject to management review or approval within the generating program area. Some program areas review prior to Civil Infractions review, some review after.
3. All NOIs that are marked defective are then identified in one of two periodic reports. The housing and property maintenance report updates continuously. Defective cases identified on the housing and property maintenance report are to be cancelled or rehabilitated within a Service Level Agreement (SLA) of three business days. The report for the remainder of the defective cases is circulated weekly so that the programs can identify cases for correction. The reports identify the specific cases that are defective and include details to assist in rehabilitation of the case. The reports are analyzed to detect trends, inform potential training, system updates, and process changes.

Correction and rehabilitation for defective NOIs are performed by program managers working with the inspector who was the source of the NOI. Sometimes cases are too defective to rehabilitate. Most cases that cannot be rehabilitated are scheduled for a new inspection to address the underlying issue. In cases where there would be no benefit to reinspecting (for example, if the agency already has proof the underlying issue is corrected) the defective case may be closed with no further action.

(a) What is the status of the Strategic Enforcement Plan?

Response: The Strategic Enforcement Plan has been prepared and is undergoing executive review.

(b) How has the department engaged community partners and stakeholders?

Response: DOB held a community engagement event on December 15, 2022 with approximately 70 participants. Part of that event was a Thought Exchange that allowed participants to submit free-form ideas on enforcement and then rate the ideas submitted. There were 197 ideas submitted and 3,065

ratings. This event was promoted through a GovDelivery message to DOB's external distribution list, which includes over 350,000 email addresses, to ensure as much input as possible.

Participants in the event included residents, business owners, licensed professionals, media, trade association members, members of Council staff and Advisory Neighborhood Commissioners. In addition, Strategic Enforcement Administrator Keith Parsons has participated in other meetings, as requested, with ANCs and other stakeholders about enforcement.

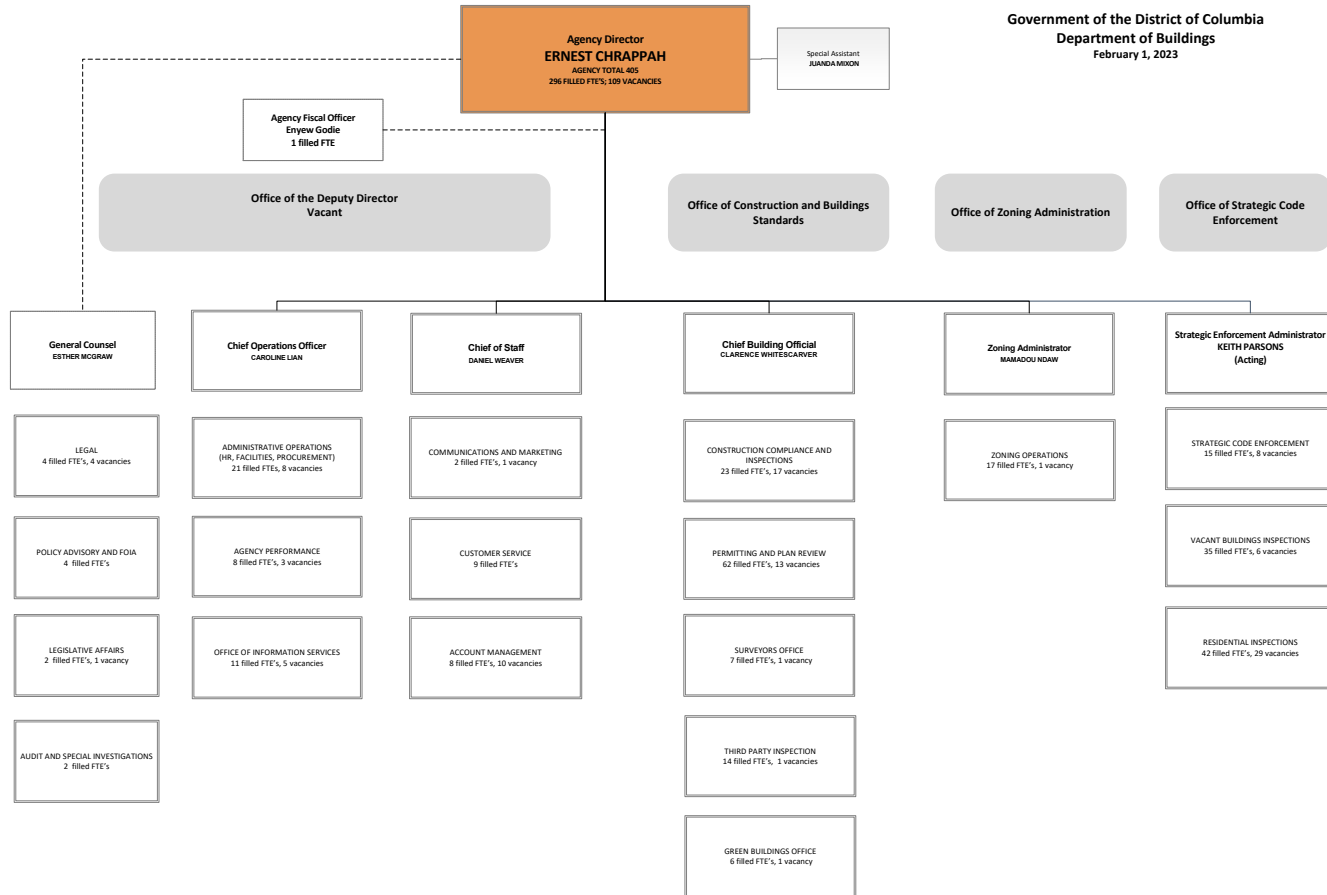
