I. BACKGROUND AND NEED

On April 27, 2023, Chairman Phil Mendelson, at the request of the Mayor, introduced PR25-228, the "Board of Massage Therapy Johanna Brooks Confirmation Resolution of 2023," which would confirm the reappointment Johana Brooks as a licensed massage therapist to the Board of Massage Therapy. Without Council action, this resolution would be deemed approved on June 17, 2023.

Pursuant to D.C. Code § 3–1202.15, the Board of Massage Therapy regulates the practice of massage therapy in the District of Columbia. The Board is comprised of five members appointed by the Mayor. Of the members of the Board, four shall be massage therapists licensed

in the District and one shall be a consumer member. Members of the Board shall be appointed for terms of 3 years.

Johanna Brooks is nominated for reappointment as a licensed massage therapist for a term to end October 29, 2023, and a new term to end October 29, 2026. She has served on the Board since 2018. She has several certifications, including as a life coach, mentor, and hypnotist. She received her Massage Therapy education from Brian Utting School of Massage in Seattle, WA, and has a BA in International Studies from American University, and dual Global Executive MBA degrees from Georgetown University & ESADE Business & Law School in Barcelona, Spain. She is a Ward 3 resident.

COMMITTEE RECOMMENDATION:

The Committee recommends the confirmation of Johanna Brooks a licensed massage therapist. Ms. Brooks is highly qualified for her reappointment to the Board of Massage Therapy. With over 14 years of experience as a licensed and practicing massage therapist, she possesses a well-rounded background and deep understanding of the profession. Her diverse work settings, including private offices, spas, hospitals, and corporate environments, demonstrate her breadth of knowledge. As an active Board Member since 2018, she has contributed to maintaining high standards for practicing professionals and advocating for improvements in education requirements. Her dedication to public safety and the well-being of District residents makes her an ideal candidate for this reappointment.

III. POSITION OF THE EXECUTIVE

The Committee did not receive any additional comments from the Executive.

IV. ADVISORY NEIGHBORHOOD COMMISSION

The Committee did not receive comments from any Advisory Neighborhood Commission.

V. SUMMARY OF STATEMENT

The Committee on Health requested responses to a questionnaire, as well as a brief written statement, from Johanna Brooks. In these documents, Ms. Brooks expressed her gratitude for the nomination to serve on the DC Board of Massage Therapy and her commitment to continuing to serve the residents of the District. With 14 years of experience as a licensed massage therapist, Johanna has worked in various settings, collaborating with different healthcare professionals and serving a diverse clientele. She highlighted the importance of a well-rounded approach in the profession, which includes technical skills and creating safe, trusted spaces for clients. Johanna also emphasized her role in promoting high standards of practice and ethics through her tenure on the Board, advocating for improvements in education requirements. She expressed her vision for revising regulations to align with current industry standards and her eagerness to collaborate with national organizations. Overall, Johanna's dedication to maintaining high standards, advancing the profession, and supporting the well-being of District residents is evident in her testimony.

VI. IMPACT ON EXISTING LAW

PR25-228 does not amend existing law.

VII. FISCAL IMPACT STATEMENT

There are no expenditures in conjunction with this legislation.

VIII. SECTION BY SECTION ANALYSIS

<u>Section 1</u> contains the long and short titles of the legislation.

<u>Section 2</u> confirms the appointment of Johanna Brooks as a licensed massage therapist member of the Board of Massage Therapy.

<u>Section 3</u> provides, upon resolution adoption, for transmittal to the nominee and the Office of the Mayor.

<u>Section 4</u> provides that the resolution shall take effect immediately.

IX. COMMITTEE ACTION

On May 31, 2023, the Committee on Health convened a mark-up at 1:54pm on PR25-228, the "Board of Massage Therapy Johanna Brooks Confirmation Resolution of 2023." Pursuant to Council Period 25 Council Rule 430(b), four Members of the Committee on Health agreed to a shorter notice to markup the measure in the Committee. The measure was circulated with Committee staff at 11:53am on May 31, 2023 and requested to be added to the agenda of the additional Committee meeting at 1:00pm, and be considered at approximately 1:45pm, on May 31, 2023. This enabled the Committee to agendize this measure for the June 6, 2023 Legislative Meeting, thus ensuring the Council had the opportunity to consider it before the passive approval date of June 17, 2023.

Present and voting were Chairperson Christina Henderson and Councilmembers Charles Allen and Brianne K. Nadeau. Chairperson Henderson gave a description of PR25-228 before opening the floor for comments from the members. Hearing no discussion, Chairperson Henderson then moved for block approval of the Committee Print and the Committee Report of PR25-228. The Committee voted 3-0 to approve the Committee Print and the Committee Report with the members voting as follows:





Good afternoon, Chairperson Henderson and members of the Committee. My name is Johanna Brooks, and it is my pleasure to receive your consideration for my nomination to serve on the DC Board of Massage Therapy. I am deeply grateful to Mayor Bowser for re-nominating me to the Board. I'm honored to have this opportunity to continue serving the residents of our District.

I have been a licensed and practicing massage therapist since April of 2000, with 14 years licensed and practicing here in the District of Columbia. My career in massage therapy led me to work in a vast range of settings, and with a tremendously diverse cross-section of people, both as clients and as colleagues.

My experiences over the past two decades have provided me with a well-rounded background essential in understanding the various aspects, viewpoints, and historical landscape of the profession. I have been fortunate to serve clients through private office practice, in world-class spas, resorts & hotels, and in collaboration with chiropractors, acupuncturists, physical therapists, OB/GYNs and general medical practitioners. I have also provided therapeutic services to clients in-home and in-hospital settings, in professional sports arenas, and through corporate employee wellbeing programs.

From 2013 until the pandemic closed our doors in March of 2020, I was the CEO and Founder of Onsite Massage, a corporate and events massage company serving organizations & companies prioritizing their employees' health and wellbeing. We also partnered with organizations like Destination DC, to provide services at convention center events & around town. I managed more than 30 licensed massage therapists as independent contractors and was able to pay above-market wages for contracted services.

Before my appointment to the Board of Massage Therapy, I served for two years as Vice President of the DC Chapter of the American Massage Therapy Association. In this role, I provided strategic direction and support to the President and to Chapter members.

Since September 2018, it has been my great pleasure to serve as a Board Member on the Board of Massage Therapy, doing my part to help ensure the standards for practicing professionals here in the District remain high. In addition to participating in bi-monthly meetings and making advisory decisions pertaining to licensing and regulation, I've been able to use my voice as an advocate for raising the bar on initial and continuing education requirements for therapists.

When I first became a massage therapist, I quickly realized that helping people understand their anatomy, physiology and kinesiology was only a fraction of what I had signed up for. The actual "massage part" of being a massage therapist was easy; ensuring that I was, in fact, educated and able to hold confidently the trust of my clients was top priority. One of the most wonderful – and yet often overlooked – aspects of our

profession is that it requires a combination of both hard & soft skills: The ability to work effectively with muscle, tendon & tissue, but also to facilitate safe and trusted spaces, to conduct needs assessments with care, and communicate with compassion – all of these are integral aspects of what we do. I care very much about supporting this well-rounded approach.

Moving forward, I am excited to continue to build upon and expand the efforts of the Board to maintain a high standard of practice and ethics for massage therapists who work in the District - and also maintain a positive, safe and healing experiences for the public that we serve. There is no doubt that the profession of Massage Therapy is a high-value offering in a sometimes high-stress city that thrives on over-achievement and excellence. I would love to see DC continue to relax, de-stress, and receive the quality of wellness support that allows its dedicated people to rest, restore themselves and keep going.

To this end, I look forward to continuing the work of revising the regulations governing practice here in the District. This will bring the regulations up to date with the current professional landscape and national norms in the areas of education and continuing education, which will provide a better framework for moving forward and serve to mitigate future questions that may arise.

I'm also eager to continue the work and dialogue we've already begun with members of the Federation of Massage Therapy Boards (FSMTB), Regulatory Education and Competence Hub (REACH), and the National Certification Board for Therapeutic Massage and Bodywork (NCBTMB) to create a comprehensive course on Ethics, Boundaries, and Code of Conduct.

The Board has an essential role in safeguarding the public, and in ensuring that the standards of care and practice here in the District remain high. It is my intention to utilize my expertise to continue working in collaboration with others who similarly support these goals. The District is a beautiful city in which to live, and the health and wellbeing of its residents is incredibly important.


