A BILL IN THE COUNCIL OF THE DISTRICT OF COLUMBIA To amend, on a temporary basis, the Youth Employment Act of 1979, to establish a Middle School Career Exploration Pilot progam to provide occupational skills, academic enrichment, life skills, career exploration, work readiness or youth development trainings. BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Middle School Career Exploration Pilot Temporary Amendment Act of 2023.". Sec. 2. The Youth Employment Act of 1979, effective January 5, 1980 (D.C. Law 3-46; D.C. Official Code § 32-241 et seg) is amended as follows: (a) Section 2 (D.C. Official Code § 32-241) is amended by adding a new paragraph (4A) to read as follows: "(4A) "Middle School Youth" means an individual who is between the ages of 9 and 13 years old.". (b) Section 2a(a) (D.C. Official Code § 32–242(a)) is amended by adding new paragraphs (6) and (7) to read as follows: "(6)(A) Middle School Career Exploration — The Department of Employment Services (DOES) shall create a summer pilot program for middle school youth that provides occupational skills, academic enrichment, life skills, career exploration, work readiness, or youth

development trainings.

33	"(B) DOES may provide an incentive to participants who participate in the
34	summer pilot program.
35	"(C) DOES shall implement the pilot program beginning June 1, 2023.
36	"(D) DOES shall be authorized to spend program funding to provide
37	meals and snacks to participants.
38	"(E) DOES shall administer a survey to participants following the
39	completion of the summer youth pilot.
40	"(F) Upon completion of the summer pilot, DOES shall submit to the
41	Council a report detailing:
42	"(i) The total number of participants who participated in the
43	program;
44	"(ii) The total number of participants who completed the program;
45	"(iii) Partner organizations with whom participants completed their
46	experiences;
47	"(iv) Participants' demographic data, as available;
48	"(v) Results from the survey administered pursuant to
49	subparagraph (E) of this paragraph.
50	"(7)(A) Middle School Year-Round Career Exploration DOES may create an
51	after-school program for middle school youth that provides occupational skills, academic
52	enrichment, life skills, career exploration, work readiness or youth development trainings during
53	the school year.
54	"(B) DOES may provide an incentive to participants who participate in the
55	year-round pilot program.

56	"(C) DOES may implement the year-round pilot program in School Year
57	2023-2024.
58	"(D) DOES shall be authorized to spend program funding to provide
59	meals and snacks to participants.".
60	Sec. 3. Applicability
61	This act shall apply as of June 1, 2023.
62	Sec. 4. Fiscal impact statement.
63	The Council adopts the fiscal impact statement of the Budget Director as the fiscal impact
64	statement required by section 4a of the General Legislative Procedures Act of 1975, approved
65	October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).
66	Sec. 5. Effective date.
67	(a) This act shall take effect following approval by the Mayor (or in the event of veto by
68	the Mayor, action by the Council to override the veto), a 30-day period of congressional review
69	as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December
70	24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
71	Columbia Register.
72	(b) This act shall expire after 225 days of its having taken effect.
