I am requesting that the following measures be agendized for the July 11, 2023 Legislative Meeting.

Emergency and Temporary Measures

- Sexual Harassment Investigation Review Emergency Declaration Resolution of 2023
- Sexual Harassment Investigation Review Emergency Act of 2023
- Sexual Harassment Investigation Review Temporary Act of 2023

These measures would direct the Office of the Inspector General to re-examine sexual harassment complaints against the mayor's former chief of staff and deputy mayor for planning and economic development, with the requirement that OIG hire independent counsel specializing in these matters to review MOLC's investigations and other complaints that were found to be out of scope. The independent counsel would also review new formal or informal complaints that may arise from employees or as part of their investigation.

This legislation would also support and effectuate the Mayor's request from June 27, 2023, for OIG to use its existing authority to undertake a management review and assessment of existing policies in need of updating.

While the Inspector General is appointed by the Mayor, they serve for six-year terms and operate independently of the Executive. After careful consideration and extensive discussion with relevant partners, we determined that OIG – along with specialized third-party counsel – is best equipped to handle such a high-profile investigation in a way that establishes greater impartiality while avoiding politicizing the matter in a way that does disservice to victims.
