Council Chairman Phil Mendelson announces the reconvening of a public roundtable before the Committee of the Whole on *DC Public Schools Food Services Contracts*. The roundtable was originally convened at 10:30 a.m. on Tuesday, August 22, 2023 and reconvened on Wednesday, September 6, 2023. The Chairman intends to reconvene the roundtable at 2:30 p.m. on Wednesday, September 13, 2023.

DC Public Schools' (DCPS) has promised that new contracts will be submitted to the Council on August 17. DCPS's food service contracts have not been competitively bid since 2016 when two contracts were awarded to two vendors to provide school meals – SodexoMagic and DC Central Kitchen. Earlier this year, it was discovered that the contracts for the incumbent vendors had expired yet been extended without Council approval. At least since early 2022 DCPS has sought to competitively rebid the contracts and submit them to the Council for approval by July. The Committee notes that the quality of meals has been criticized. This hearing will give the public an opportunity to weigh in on the proposed vendors and for DCPS to explain how the new vendors will deliver healthy and appetizing school lunches beginning in school year 2023-24.
