10 17	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
18	act may be cited as the "CJCC Data Collection Technical Correction Emergency Amendment
19	Act of 2023".
20	Sec. 2. Section 1501 of the Criminal Justice Coordinating Council for the District of
21	Columbia Establishment Act of 2011, effective October 3, 2001 (D.C. Law 14-28; D.C. Official
22	Code § 22-4234), is amended by adding new subsections (b-5) and (b-6) to read as follows:
23	"(b-5) By October 1, 2023, and on a quarterly basis thereafter, the CJCC shall submit to
24	the Mayor and the Council and post on its website a report that includes the following
25	information, in accordance with existing law: Aggregate data on processes and outcomes for
26	criminal and juvenile justice diversion, pretrial supervision, detention, prosecution, sentencing,
27	incarceration, probation, parole, supervised release, deferred prosecution agreements, deferred
28	sentencing agreements, deferred disposition agreements, and consent decrees.
29	"(b-6) The CJCC shall post the following year-to-date data on its website monthly,
30	beginning with the earliest year for which CJCC is able to obtain historical data:
31	"(1) Arrests for violent crimes committed by juveniles and adults, by offense; and

34	Sec. 3. Section 5 of the Prioritizing Public Safety Temporary Amendment Act of 2023,
35	passed on 2nd reading on September 19, 2023 (Enrolled version of Bill 25-396), is repealed.

41	This act shall take effect following approval by the Mayor (or in the event of veto by the

44	412(a) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 788;
