A BILL

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To amend, on a temporary basis, the Criminal Justice Coordinating Council for the District of Columbia Establishment Act of 2011 to clarify the requirement that the CJCC report aggregate programmatic data on process and outcomes of programs.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the “CJCC Data Collection Technical Correction Temporary Amendment Act of 2023”.

Sec. 2. Section 1501 of the Criminal Justice Coordinating Council for the District of Columbia Establishment Act of 2011, effective October 3, 2001 (D.C. Law 14-28; D.C. Official Code § 22-4234), is amended by adding new subsections (b-5) and (b-6) to read as follows:

“(b-5) By October 1, 2023, and on a quarterly basis thereafter, the CJCC shall submit to the Mayor and the Council and post on its website a report that includes the following information, in accordance with existing law: Aggregate data on processes and outcomes for criminal and juvenile justice diversion, pretrial supervision, detention, prosecution, sentencing, incarceration, probation, parole, supervised release, deferred prosecution agreements, deferred sentencing agreements, deferred disposition agreements, and consent decrees.

“(b-6) The CJCC shall post the following year-to-date data on its website monthly, beginning with the earliest year for which CJCC is able to obtain historical data:

“(1) Arrests for violent crimes committed by juveniles and adults, by offense; and

32 “(2) Gun violence and homicide counts and rates citywide and by ward,

34 Sec. 3. Section 5 of the Prioritizing Public Safety Temporary Amendment Act of 2023,
35 passed on 2nd reading on September 19, 2023 (Enrolled version of Bill 25-396), is repealed.

36 Sec. 4. Fiscal impact statement.

37 The Council adopts the fiscal impact statement of the Budget Director as the fiscal impact
38 statement required by section 4a of the General Legislative Procedures Act of 1975, approved
39 October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).

40 Sec. 5. Effective date.

41 (a) This act shall take effect following approval by the Mayor (or in the event of veto by
42 the Mayor, action by the Council to override the veto), a 60-day period of Congressional review
43 as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December
44 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
45 Columbia Register.

46 (b) This act shall expire after 225 days of its having taken effect.
