22	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
23	act may be cited as the "Medical Cannabis Patient Access Clarification Temporary Amendment
24	Act of 2023".
25	Sec. 2. The Legalization of Marijuana for Medical Treatment Initiative of 1999, effective
26	February 25, 2010 (D.C. Law 13-315; D.C. Official Code § 7-1671.01 et seq.), is amended as
27	follows:
28	(a) Section 2 (D.C. Official Code § 7-1671.01) is amended as follows:
29	(1) The existing paragraph (1E) is redesignated as paragraph (1F).
30 31	(2) A new paragraph (1E) is added to read as follows:
31 32	"(1E) "Another jurisdiction" means any state, commonwealth, or territory of the
33	United States.".

34	(3) Paragraph (13B) is amended by striking the phrase "resident who" and
35	inserting the phrase "resident who is a person who resides or is domiciled in another state,
36	territory, foreign country, or foreign territory and who" in its place.
37	(4) Paragraph (19) is amended as follows:
38	(A) Strike the phrase "dental treatment, or" and insert the phrase "dental
39	treatment, a patient who is a non-resident cardholder, or" in its place.
40	(B) Strike the phrase "provided, that a patient" and insert the phrase
41	"provided, that a patient who is a non-resident cardholder or a patient" in its place.
42	(b) Section 6(b)(15) (D.C. Official Code § 7-1671.05(b)(15)) is amended by striking the
43	phrase "Establish sliding-scale registration and annual renewal fees for all persons and entities
44	required to register or obtain a license pursuant to this act; provided" and inserting the phrase
45	"Establish registration, sliding-scale registration, and annual renewal fees for all persons and
46	entities required to register or obtain a license pursuant to this act and permit the ABC Board,
47	by rule, to make qualifying patient and caregiver registrations available at no cost; provided" in
48	its place.

50	(a) Section 5(a)(1)(H) of the General Obligation Bonds and Bond Anticipation Notes for
51	Fiscal Years 2023-2028 Authorization Act of 2023, effective June 14, 2023 (D.C. Law 25-9; 70
52	DCR 6095), is amended by striking the number "(6)" and inserting the word "Recreation" in its

60	(a) This act shall take effect following approval by the Mayor (or in the event of veto by
61	the Mayor, action by the Council to override the veto), a 30-day period of Congressional review
62	as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December
63	24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
64	Columbia Register.

65 (b) This act shall expire after 225 days of its having taken effect.
