of the Food Policy Council. The roundtable will be held on Wednesday November 29, 2023, at 10:30a.m.

The stated purpose of PR25-0399 is to confirm Mr. José Funk McDonald Morales as a member of the Food Policy Council, replacing Christopher Bradshaw, for a term to end March 1, 2026. The stated purpose of PR25-0529 is to confirm Caroline Howe as Food Policy Director. The stated purpose of PR25-0502 is to confirm Sheila Holt for reappointment as a marriage and family therapist member of the Board of Marriage and Family Therapy, for a term to end February 5, 2026. The stated purpose of PR25-0504 is to confirm Iris Morton for reappointment as a licensed dentist member of the Board of Dentistry, for a term to end November 30, 2025. The stated purpose of PR25-0505 is to confirm John Bailey for reappointment as a licensed dentist member of the Board of Dentistry, for a term to end November 30, 2025.

The Committee will also hold a FY2023 public oversight roundtable on the DC Food Policy Council (FPC) to evaluate any initiatives, progress, and challenges. FPC is a coalition of public and government food leaders appointed by the Mayor to create a just, healthy, equitable and sustainable food system for all by engaging, empowering, and informing DC residents and effecting positive policy change.

Witnesses will be appearing virtually using the Zoom platform. Public witnesses will have 5 minutes to speak if they are representing an organization, and 3 minutes if they are speaking for themselves. Witnesses who anticipate needing spoken language interpretation, or require sign language interpretation, are requested to inform the Committee office of the need as soon as possible but no later than five business days before the proceeding. We will make every effort to fulfill timely requests, although alternatives may be offered. Requests received in less than five business days may not be fulfilled.
