Approval and Payment Authorization Emergency Declaration Resolution of 2023". Sec. 2. (a) There exists an immediate need to approve Modifications 9 and 10 to Contract No. NFPHCNUR-19-C-003 ("Contract") between the Not-for-Profit Hospital Corporation ("Hospital") and Contemporary Nursing Solutions Inc., for the provision of specialty and non-specialty temporary assignment nurses and to authorize payment for the services received and to be received under this Contract.

37	(b) UMC has an ongoing need for specialty and non-specialty temporary
38	assignment nurses. The growing cost of staffing services, the Hospital's staffing needs,
39	changing staffing agency costs, and the pending wind down all contributed to the
40	contract's retroactivity.
41	(c) Modifications 7 and 8 in the amount of \$1,600,000 for Option Year 3 (October
42	31, 2022 – October 30, 2023) was approved by Council as A25-120.
43	(d) If proposed Modification 9 to Option Year 3 for \$1,500,000 is approved, the
44	aggregate value (\$3,100,000) of Option Year 3 (October 31, 2022 – October 30, 2023)
45	would have an aggregate value that exceeds \$1 million in a 12-month period, and
46	therefore Council approval is necessary.
47	(e) If proposed Modification 10 seeking to exercise Option Year 4 (October 31,
48	2023 - October 30, 2024) in the amount of \$3,000,000 is approved, it would have an
49	aggregate value that exceeds \$1 million in a 12-month period, and therefore Council
50	approval is also necessary.
51	(f) Without these approvals, Contemporary Nursing Solutions Inc. cannot be paid
52	for these critical services provided and to be provided in excess of \$999,999.99.
53	Sec. 3. The Council determines that the circumstances enumerated in section 2
54	constitute emergency circumstances making it necessary that Modifications 9 and 10 to
55	Contract No. NFPHCNUR-19-C-003 between the Not-for-Profit Hospital Corporation
56	and Contemporary Nursing Solutions Inc. Approval and Payment Authorization
57	Emergency Amendment Act of 2023, be adopted after a single reading.
