The stated purpose of PR25-0561 is to appoint Judy Brinckerhoff as the health professional licensed in the District who has experience in long-term care member of the Board of Long-Term Care Administration, filling a vacant seat, for a term to end July 21, 2025. The stated purpose of PR25-0575 is to reappoint Victoria Sherk as a person with at least five years of experience in the field of addiction counseling member of the Board of Professional Counseling, for a term to end July 1, 2026. The stated purpose of PR25-0576 is to appoint Giovanna Di Lauro as a professional counselor licensed in the District member of the Board of Professional Counseling, for a term to end July 1, 2024. The stated purpose of PR25-0574 is to appoint Rhonda Brown as a professional counselor licensed in the District member of the Board of Professional Counseling, for a term to end July 1, 2025. Finally, the stated purpose of PR25-0578 is to appoint Omololu Majekodunmi as an occupational therapist licensed in the District member of the Board of Occupational Therapy, filling a vacant seat, for a term to end April 16, 2024.
