On Thursday, January 18, 2024, Councilmember Charles Allen, Chairperson of the Committee on Transportation and the Environment, will convene a public roundtable to consider PR25-567, the “District of Columbia Water and Sewer Authority Board of Directors Richard Jackson Confirmation Resolution of 2023,” and PR25-568, the “District of Columbia Water and Sewer Authority Board of Directors Keith Anderson Confirmation Resolution of 2023.” The hearing will be conducted in person and virtually via the Zoom platform and in Room 123 of the John A. Wilson Building from 10:00 a.m. to approximately 1:00 p.m.

The stated purpose of PR25-567 is to confirm the appointment of Richard Jackson, currently the Director of the Department of Energy and Environment, to the Board of Directors of DC Water. Director Jackson would replace Tommy Wells as a cabinet-level officer member of the Board, for a term to end September 12, 2024.

The stated purpose of PR25-568 is to confirm the appointment of Keith Anderson, currently the Deputy Mayor for Operations and Infrastructure, to the Board of Directors of DC Water. Deputy

Mayor Anderson would replace Wendell Felder as a District resident member of the Board, for a term to end September 12, 2027.

The Committee invites the public to provide oral and written testimony. Public witnesses seeking to provide oral testimony at the Committee's roundtable must thoroughly review the following instructions:

- Anyone wishing to provide oral testimony must register using the Council's Hearing Management System at <https://lims.dccouncil.gov/hearings> by the **close of business on Tuesday, January 16, 2024.**
- The Committee will approve witnesses' registrations based on the total time allotted for public testimony. The Committee will also determine the order of witnesses' testimony.
- Representatives of organizations will be allowed a maximum of five minutes for oral testimony, and individuals (and any subsequent representatives of the same organizations) will be allowed a maximum of three minutes. In order to accommodate additional public witnesses, the Committees may reduce witnesses' allotted time for testimony but will inform witnesses if it plans to do so.
- Witnesses are not permitted to yield their time to, or substitute their testimony for, the testimony of another individual or organization.
- Testimony should be submitted through the Council's Hearing Management System <https://lims.dccouncil.gov/hearings> in advance of the roundtable. Testimony will be publicly accessible upon Committee review.
- Witnesses who anticipate needing language interpretation, including ASL interpretation, are requested to inform the Committee on Transportation and the Environment as soon as possible, but no later than five business days before the roundtable by emailing [cote@dccouncil.gov](mailto:cote@dccouncil.gov). The Committees will make every effort to fulfill timely requests; however, requests received fewer than five business days before the roundtable may not be fulfilled and alternatives may be offered.

For witnesses who are unable to testify at the roundtable, written statements will be made part of the official record. Copies of written statements should be submitted through the Council's Hearing Management System <https://lims.dccouncil.gov/hearings>. **The record will close at the end of the business day on Thursday, January 25, 2025.**
