18	BE IT ENACTED BY THE COUNCIL DISTRICT OF COLUMBIA, That this act may
19	be cited as the "Reverse Mortgage Insurance and Tax Payment Program Second Extension
20	Congressional Review Emergency Amendment Act of 2024".
21	Sec. 2. Section 307a of the District of Columbia Housing Finance Agency Act, effective
22	October 30, 2018 (D.C. Law 22-168; D.C. Official Code § 42-2703.07a), is amended as follows:
23	(a) Subsection (a) is amended as follows:
24	(1) Paragraph (1) is amended by striking the phrase "property taxes and
25	property insurance debts" and inserting the phrase "property taxes, property insurance debts,
26	condominium fees, and homeowners association fees" in its place.
27	(2) Paragraph (3) is repealed.
28	(b) Subsection (d) is amended by striking the number "25,000" and inserting the
29	number "40,000" in its place.
30	(c) Subsection (e) is repealed.
31	(d) Subsection (f)(1) is amended as follows:

32	(1) Subparagraph (A) is amended by striking the phrase "pay property
33	taxes or insurance premiums" and inserting the phrase "pay property taxes, insurance premiums,
34	condominium fees, or homeowner association fees" in its place.
35	(2) Subparagraph (B) is amended by striking the phrase "balances of
36	property taxes and insurance premiums" and inserting the phrase "balances of property taxes,
37	insurance premiums, condominium fees, homeowner association fees" in its place.
38	Sec. 3. Applicability.
39	This act shall apply as of March 24, 2023.
40	Sec. 4. Fiscal impact statement.
41	The Council adopts the fiscal impact statement of the Budget Director as the fiscal impact
42	statement required by section 4a of the General Legislative Procedures Act of 1975, approved
43	October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).
44	Sec. 5. Effective date.
45	This act shall take effect following approval by the Mayor (or in the event of veto by the
46	Mayor, action by the Council to override the veto), and shall remain in effect for no longer than
47	90 days, as provided for emergency acts of the Council of the District of Columbia in section
48	412(a) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 788;
49	D.C. Official Code § 1-204.12(a)).
