A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve Contract No. CW103314 with Henry’s Soul Café, Inc., and Modification Nos. 1, 2, 3, 4 and 5 thereto, and to authorize payment for the goods and services received and to be received under the contract and modifications.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the “Contract No. CW103314 with Henry’s Soul Café, Inc. Approval and Payment Authorization Emergency Declaration Resolution of 2024”.

Sec. 2. (a) There exists a need to approve Contract No. CW103314 with Henry’s Soul Café, Inc., and Modification Nos. 1, 2, 3, 4 and 5 thereto, and to authorize payment for the goods and services received and to be received under the contract and modifications.

(b) On November 1, 2022, the Office of Contracting and Procurement (“OCP”), on behalf of the Department of Human Services, executed Contract No. CW103314 with Henry’s Soul Café’, Inc., for emergency meal services for migrant families and individuals from the Arizona-Mexico and Texas-Mexico borders, with a base period of November 1, 2022 through September 30, 2023 in the not-to-exceed amount of \$4,000,000.

35 (c) Modification No. 1 was an administrative modification.

36 (d) By Modification No. 2, dated September 30, 2023, the Office of Contracting
37 and Procurement, on behalf of the Department of Human Services, extended the base
38 period by one month to October 31, 2023, at no cost to the District.

39 (e) By Modification No. 3, OCP partially exercised option year one of the
40 contract for the period November 1, 2023 through February 14, 2024, in the not-to-
41 exceed amount of \$950,000.

42 (f) Proposed Modification No. 4 would exercise the remainder of option year one
43 of the contract for the period February 15, 2024 through October 31, 2024 in the not-to-
44 exceed amount of \$3,802,840, thereby increasing the total not-to-exceed amount of
45 option year one to \$4,752,840.

46 (g) Modification No. 5 deleted Section B.4 (Price Schedule) in its entirety and
47 replaced it with revised section B.4. See Attachment A.

48 a. Option two and three price schedule is deleted in its entirety.

49 (h) Under section 451(b) of the District of Columbia Home Rule Act, approved
50 December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-204.51(b) (1)), Council
51 approval is necessary since the base period and the modifications are both in excess \$1
52 million during separate 12-month periods.

53 (i) Approval is necessary to allow the continuation of these vital services.
54 Without this approval, Henry's Soul Café, Inc. cannot be paid for goods and services
55 provided in excess of \$1 million for the contract period November 1, 2022 through
56 October 31, 2023 or the contract period November 1, 2023 through October 31, 2024.

57 Sec. 3. The Council determines that the circumstances enumerated in section 2
58 constitute emergency circumstances making it necessary that the Contract No.

59 CW103314 with Henry's Soul Café, Inc. Approval and Payment Authorization

60 Emergency Act of 2024 be adopted after a single reading.

61 Sec. 4. This resolution shall take effect immediately.
