On Thursday, May 30, 2024, Councilmember Kenyan R. McDuffie, Chairperson of the Committee on Business and Economic Development, will hold a public roundtable to consider the following measures:

- Proposed Resolution 25-0687, the “Washington Convention and Sports Authority Board of Directors Leif Dormsjo Confirmation Resolution of 2024”
- Proposed Resolution 25-0751, the “Provident Group Girard Properties Inc. Revenue Bonds Project Approval Resolution of 2024”
- Proposed Resolution 25-0752, the “D.C. Preparatory Academy Revenue Bonds Project Approval Resolution of 2024”

Proposed Resolution 25-0687, the “Washington Convention and Sports Authority Board of Directors Leif Dormsjo Confirmation Resolution of 2024” would confirm the appointment of Leif Dormsjo as a public member and chairperson of the Washington Convention and Sports Authority Board of Directors, for a term to end May 16, 2026.

Proposed Resolution 25-0751, the “Provident Group Girard Properties Inc. Revenue Bonds Project Approval Resolution of 2024” would authorize the issuance, sale, and delivery in an aggregate principal amount not to exceed \$15,000,000. These bonds will be used for the financing, refinancing, or reimbursing of costs incurred by Provident Group Girard Properties Inc. for its project located at 654 Girard Street, NW, in Ward 1.

Proposed Resolution 25-0752, the “D.C. Preparatory Academy Revenue Bonds Project Approval Resolution of 2024” would authorize the issuance, sale, and delivery of tax-exempt revenue bonds, notes, or other obligations in an aggregate principal amount not to exceed \$45,000,000.00. These bonds will be used for the financing, refinancing, or reimbursing of costs incurred by D.C. Preparatory Academy for projects located at 2330 Pomeroy Road SE, and 1409 V Street SE.

The Committee invites the public to testify, in-person or virtually, and to submit written testimony. Those who wish to testify must register using the Council’s Hearing Management System at <https://lims.dccouncil.gov/hearings> by **5:00 p.m. on Tuesday, May 28, 2024.** All public witnesses will be allowed a maximum of three minutes to testify. At the discretion of the Chair, the length of time provided for oral testimony may be reduced or extended.

Public witnesses who request to participate virtually via the Zoom Video Conference platform will receive instructions by email on how to participate prior to the hearing. Written testimony should be submitted through the Council’s Hearing Management System at <https://lims.dccouncil.gov/hearings> in advance of the hearing. Written testimony will be publicly accessible upon Committee review and be made a part of the official record. The record will close at **5:00 p.m. on Monday, June 3, 2024.**

Witnesses who anticipate needing spoken language interpretation, or require sign language interpretation, are requested to inform the Committee by email of the need as soon as possible but no later than five business days before the proceeding. The Committee will make every effort to fulfill timely requests, although alternatives may be offered.
