

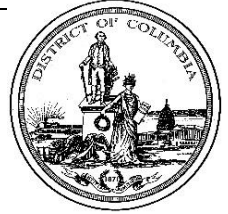

The purpose of PR25-0810 is to appoint Jeanne Moorehead as a member of the Office of Employee Appeals, filling a vacant seat formerly held by Jelani Freeman, for the remainder of an unexpired

term to end April 6, 2028. This nomination will be deemed disapproved on November 10, 2024, unless a resolution of approval or disapproval is introduced.

The stated purpose of PR25-0811 is to appoint Lashon Adams, as a member of the Office of Employee Appeals, filling a vacant seat formerly held by Peter Rosenstein, for the remainder of an unexpired term to end April 6, 2030. Oral testimony will be limited to 5 minutes for those testifying on behalf of an organization and 3 minutes for those testifying on behalf of themselves. The deadline to register to testify is Friday, June 28, 2024 at 5:00 p.m.

If someone is unable to testify at the public hearing, written statements are encouraged and will be made a part of the official record. Written statements should be submitted through the Hearing Management System at <https://lims.dccouncil.gov/hearings> or mailed to the Committee on Executive Administration and Labor, John A. Wilson Building, 1350 Pennsylvania Avenue, N.W., Suite 116, Washington, D.C. 20004. The record will close at 5:00 p.m. on Tuesday, July 16, 2024.
