Confirmation Resolutions

- **PR 25-795, the “Director of Homeland Security and Emergency Management Agency William “Clint” Osborn Confirmation Resolution of 2024”**

PR25-795 would confirm William “Clint” Osborn as the Director of the Homeland Security and Emergency Management Agency. The measure was approved unanimously by the Committee on the Judiciary and Public Safety on July 2, 2024 and was timely filed with the Office of the Secretary.

Permanent Legislation

- **B25-247, the “Female Genital Mutilation Prohibition Act of 2024”**

This bill would prohibit the practice of Female Genital Mutilation (FGM) of any person in the district. It would also require the Department of Health to educate the public on existing female genital mutilation mandated reporter reporting requirements and provide the opportunity for a survivor or victim of FGM to file a civil action against a person for committing female genital mutilation against them.

This measure was approved unanimously by the Committee on the Judiciary and Public Safety on July 2, 2024 and was timely filed with the Office of the Secretary.
