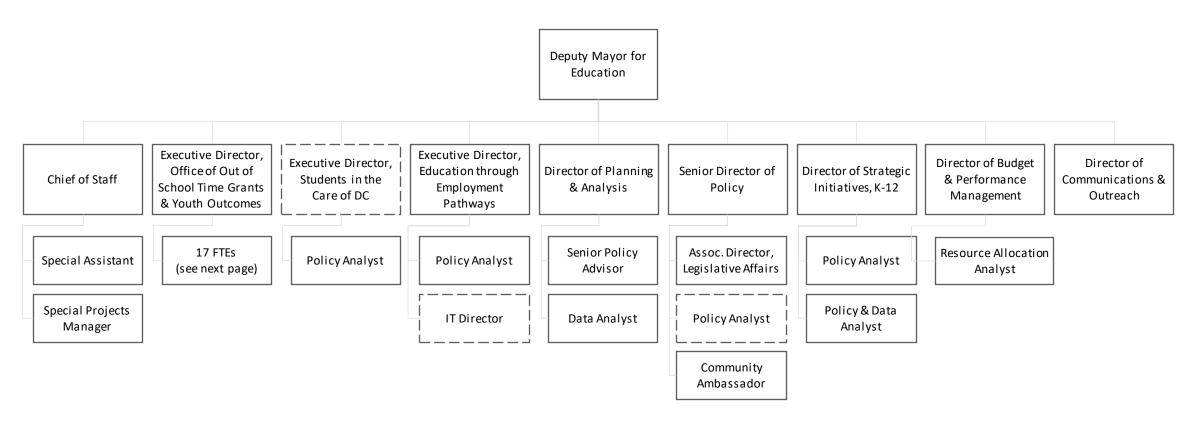
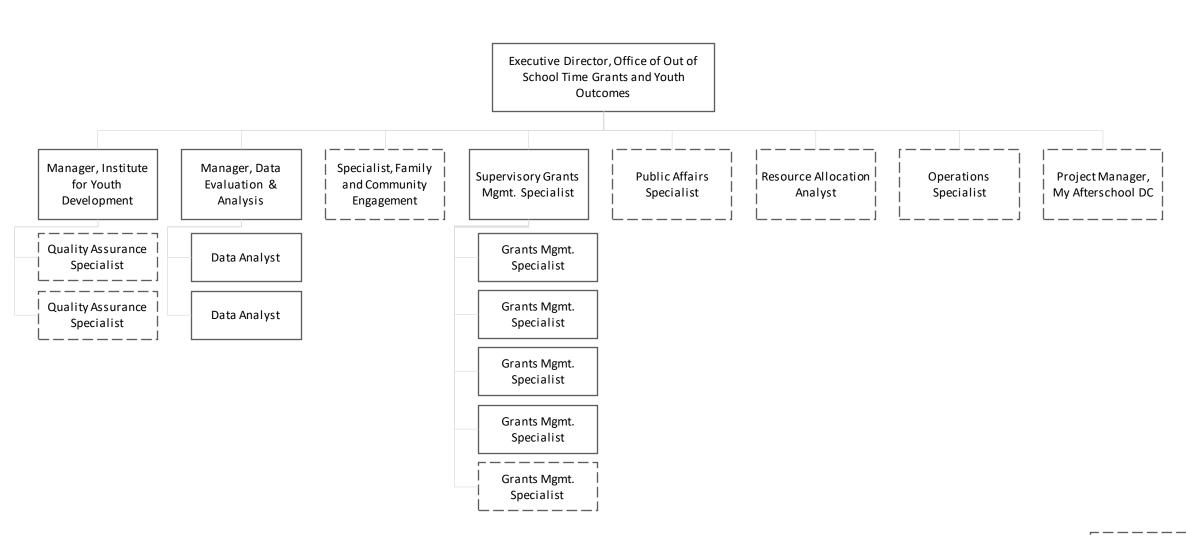
DME Organizational Chart (1/2)
