ORGANIZATION AND OPERATIONS

The mission of the Office of Chief Medical Examiner (OCME) is to ensure that justice is served and that the health and safety of the public is improved by conducting quality death investigations and certification, and providing forensic services for government agencies, health care entities, and grieving families.

OCME Divisions are as follows:

Offices of the Chief & Administration Division

The Office of the Chief is responsible for oversight of the operational and programmatic functions of the OCME, including establishing the vision and mission for the organization. The Office of Administration provides administrative services and support to the staff of the OCME. These services include personnel management (timekeeping, training and educational development, and labor relations); contracting and procurement; risk, fleet, property, and financial management; information technology; legal services; communications; and agency performance management.

Death Investigation Division

The Death Investigation Division includes:

- a) Forensic pathology, which involves conducting decedent examination, certifying the cause and manner of death, and providing that information to next of kin and law enforcement, as well as designated government entities and other interested parties;
- b) forensic investigation includes scene response, information gathering, medical records review, and provision of information to aid in the determination of the cause and manner of death;
- c) anthropology and identification unit, which administers the agency's Decedent Identification Program, ensuring that identifications are made in an accurate and efficient manner;
- d) a histology laboratory, which processes samples of tissue in support of cause and manner of death findings;
- e) mortuary services, which provides body disposition and autopsy support to forensic pathology staff and the funeral industry; and
- f) the medical examiner transport team, which ensures timely response and removal of decedents from scenes, homes, and hospitals for examination and disposition by the OCME.

Forensic Toxicology Laboratory Division

The OCME Forensic Toxicology Laboratory maintains industry standards of practice for the detection, identification, and quantitation of alcohol, drugs, and other toxins in biological specimens. The Laboratory provides scientific support services to post-mortem testing, driving under the influence testing, and drug-facilitated sexual assault testing so that the agency may provide accurate death investigation and certification information in a timely manner to next of kin, law enforcement agencies, legal counsel, and the community when required. The Forensic Toxicology Laboratory Division also administers the District's Breath Program.

Fatality Review Program Division

The Fatality Review Program reviews the circumstances of the deaths of individuals within certain populations, including their interaction with District government services. The purpose of the reviews is to provide analysis and recommendations to the public and District entities serving defined populations, so they can address systemic problems, provide better services, and be held accountable. The Fatality Review Division currently supports five Fatality Review Committees: the Child Fatality Review Committee (CFRC); Developmental Disabilities Fatality Review Committee; Maternal Mortality Review Committee.

OCME Facility Renovation - \$1,744, 812.71 (as of 1/4/24)

This project is two-fold. First, the agency must implement Phase II of its facility renovation which will provide additional spacing to include staff seating and offices, as well as storage. The project also supports funding for the agency's build-out of the Continuity of Operations Plan (COOP) with regard to replacement of the COOP site roof, pavement of the parking lot, security upgrades (fencing and security system), and renovation of internal space for mortuary operations and storage space for COOP supplies and equipment. Accrediting bodies require that the agency have a COOP site and mass fatality plan. The agency expects the COOP renovation to provide a base camp for a field operations center (which would have been invaluable during the COVID-19 pandemic where the agency built out all of its operation). The completion date for the office renovation portion of the project is anticipated to be the end of the 2024 calendar year and for the COOP portion at the end of FY26. All monies are planned to be spent.

Equipment Replacement - \$1,365,070.02 (as of 11/14/23)

Toxicology Laboratory equipment and instrumentation must be replaced when reaching approximately 7-10 years of age per industry and accreditation standards. Laboratory equipment is expensive and current local funding only provides for the procurement of three-four small instruments of over 30 instruments. Aged equipment results in increased maintenance costs. The death investigations division must also maintain equipment per industry and accreditation standards. Adequate equipment allows the agency to consistently perform toxicology testing such that the laboratory can meet its KPIs. The laboratory must also maintain modern equipment to ensure accuracy and reliability for next of kin stakeholders, law enforcement, and the court system and for purposes of accreditation. The inability to replace equipment prevents the laboratory from utilizing up to date models which ensures better turnaround times and improved services to families in completion of autopsy reports; as well as addressing emerging drugs. The equipment replacement is ongoing, and all monies are planned to be spent by the end of FY24.

The agency follows the investigation guidelines outlined in Mayor's Order 2023-313 that obligate the appointment and training of an agency sexual harassment officer to review and investigate initial complaints of sexual harassment. The agency has had no allegations of sexual harassment, sexual misconduct, or discrimination by or against agency employees in FY23 and FY24 to date.

In FY23, the agency received a complaint of misconduct by one of its employees against an employee of another agency. The complaint was referred to the other agency for resolution and disposition. The complaint was resolved.

What are three areas, programs, or initiatives within your agency where you see the most opportunity to make progress toward racial equity?

The agency hosts an annual public burial for those remains that were not claimed by next of kin or friends at the time of death. These decedents were cremated, and the cremains stored. The dignity and respect of all decedents is paramount, regardless of the person's race, in ensuring proper disposition or burial. Secondly, the agency ensures that it adheres to racial equity policies within its hiring protocols and practices. Third, the agency treats all customers with respect and provides excellent customer service without regard to race. 25. In FY23 and FY24, to date, what are two ways that your agency has addressed racial inequities internally or through the services you provide?

The agency continues to support the District's racial equity initiative. The enforcement of such policies is the responsibility of all management staff who have been trained on this issue. Secondly, the agency ensures that hiring practices are in compliance with racial equity policies of the District.

Statistical/cluster case reviews are cases grouped into like themes that the committee/board is interested in examining to assist in making recommendations on the ways to mitigate violence or prevention of the death in the District. These may be based on specific populations, place of death, cause/ manner of death, or a factor the cases have in common.

For example, the VFRC has conducted statistical reviews to include but not limited to the following:

- 19-to-24-year-olds (not involved with child welfare)
- Involvement with the justice system
- Cases that are deemed domestic in nature (per MPD and DVFRB)
- DC residents who died outside of the District
- Non-DC residents who died in the District

After the VFRC cases have been sectioned into groups, the specialist looks to see what information and records are available for those cases. While each case is examined during this process, the details found in a full case review are not presented in the statistical case review. This information is then aggregated to show general demographic data, what agencies had contact with the decedents, and any other pertinent information that can be found through an on-line search of the decedent's life. Similar processes are used for the IMRT and OFRB statistical case reviews.

h. Please describe the efforts by staff on fatality review committees to compile and gather information for case reviews.

As shared in prior testimony, the fatality review process is highly complex, labor intensive, and requires extensive analysis of multi-system records (often over thousands of pages to review) for the purpose of identifying risk/protective factors on multiple levels (individual, family, community, environmental, institutional, etc.) and the circumstances leading to the death. This is case specific and depends heavily on the level of involvement with the system and is all information that cannot be obtained from a birth/death certificate alone. Staff request records (from all DC/private agencies and the systems outlined below), receive/upload documents, and review and analyze the documents and compiled information into a comprehensive case summary for the Committee's/Board's review.

Death Occurs of DC Resident: -OCME Case (Not all deaths are OCME cases) -DC Health Vital Records - Obtain birth and death certificates indicating official cause and manner of death

Additionally, staff compile information into the committee/board decision form (for MMRC and OFRB) and plan and implement quarterly committee/board recommendations sub-committee meetings. Staff also attend other internal agency (CFSA and DDS) fatality review processes in an effort to obtain any additional information on case discussions to incorporate in the review process. Staff also hold briefings with members of private organizations to facilitate case reviews and ensure the appropriate information has been obtained.

i. For each fatality review committee, please provide the average time it takes for a case to be presented to a committee from the date of the decedent's death.

Placing this information in a reportable fashion continues to be a challenge. Staff must first obtain information about the service history and interactions of decedents with all DC agencies. Once agencies have been identified, service history is requested and upon receipt of all necessary information, the case summary is completed (or statistical report compiled) and presented to the Committee/Board for member review. Although we may believe we have all records necessary for a review, upon analysis of the records, additional service providers and/or records (due to specific incidents) may be recognized and additional information is then requested, analyzed, and incorporated into the report.

During this reporting period, the CFRC reviewed several cases that were under "open litigation" which created additional barriers in response time as some entities were not timely or forthcoming with information requiring the committee to issue subpoenas and hold individual meetings to compel entities to share information and/or participate in case review meetings. Additionally, in these types of cases, members with direct knowledge or involvement in the case, due to litigation status, were unable to participate in meetings and share information, outcomes, and findings which further impeded the Committee's efforts to make recommendations.

The fatality review staff attempt to ask the "fourth and fifth question" and anticipate member questions such that all necessary information is presented to the Committee/Board with the overall goal of generating systemic recommendations and discussion. Staff also make efforts to contact agencies and service providers prior to meetings to inform as to questions the committee may make such that they can come to meetings prepared to address information or concerns. As a result of prior year's CFRC legislative changes, this information has been tracked on a more consistent basis; however, due to high fatality numbers, and continued/carried over case discussions during meetings, it has been difficult to review cases within the mandated time frames. Cases with limited agency involvement do not take as long to prepare for review; however, the majority of cases are those with lengthy service involvement and they take significantly longer to prepare and for the Committee to review.

The MMRC published its 2021 MMRC Annual Report in September 2023 and held its public symposium during the October 24, 2023 MMRC meeting. The OCME staff developed a draft of the 2022 MMRC Annual Report and presented it to the MMRC Annual Report sub-group assisting with content edits in July 2023. An updated draft of the 2022 MMRC Annual Report was presented to the full committee for review and further discussion and will be brought back during the MMRC January 2024 meeting for any additional discussion and final voting for approval of the report. The 2023 MMRC Annual Report is currently being drafted OCME and the Committee hope to have the report published by the July 1st requirement.

The 2021 OFRB Annual Report was published in May 2023. The OFRB received a draft of the 2022 OFRB Annual Report in September 2023, and they reviewed and approved the content of the report the same month. The fatality review division staff are working to publish the report "in-house". OCME and the Board anticipate that once the necessary publishing software has been procured, all pending agency responses to recommendations have been received, and some training on the utilization of the publishing software commences, the report will be published. Fatality review division staff have also started the process of extracting data for the 2023 OFRB Annual Report which is scheduled for completion at the end of the fiscal year.

The 2021 DDFRC Annual Report has been approved by the Committee and is awaiting publishing. The 2022 DDFRC Annual Report was completed by a vendor and presented to the Committee during the January 2024 meeting. The Committee is in the process of editing the report and OCME and the Committee anticipate the report will be approved by the Committee in February 2024 and submitted for in-house publishing with an anticipated publishing date of June 2024. The compilation of data for the 2023 DDFRC Annual Report is underway and procurement for a vendor to complete the report will be forthcoming and OCME anticipates the report will be approved by the Committee at the end of the fiscal year and published publicly thereafter.

32. In its FY22 responses, the agency said that it has decommissioned the Thrive By Five DC project. Has the agency found other ways to achieve this project's goals inFY23 and FY24, to date, since decommissioning the project?

Due to logistics and staffing resources, there were no additional activities taken on the Thrive by Five DC safe sleep project on behalf of the OCME. The funding for this project is no longer available. There are various agencies within the public and private sectors addressing safe sleep.

33. Please provide an update on OCME's quality assurance efforts. In its FY22 responses, the agency said that "quality assurance implementation activities were placed on hold" and would "resume during FY23 Q2." Please provide an update on OCME Opioid Forensic Investigators' quality assurance efforts to ensure bystanders are interviewed by the MDI/FI and asked the six mandatory questions recommended by the OFRB.

On May 4, 2023, the Opioid Fatality Review Board (OFRB) met with Chief Information Officer, Mike Coleman; Supervisory Quality Control and Records Manager, Anna Francis; and Lead Forensic Investigator, Julie Wolf, Lead FI (representing Supervisor of Investigations) to discuss the mandatory questions recommended by the OFRB. There was discussion as to the official response to the Board that was sent on behalf of Dr. Roger Mitchell (former Chief Medical Examiner) and Dr. Diaz after their review. There are six questions the OFRB is requesting to be asked of the families of decedents who possibly overdosed. There is no barrier to the Forensic Investigators obtaining information from families upon inquiry or interview; however, there is currently no mechanism in the agency's Case Management System (CMS) to capture the answers and/or information in a format that can be queried.

The CMS is utilized to store medical examiner case data which is extracted for provision to next of kin and various stakeholders, such as law enforcement, other District agencies, DC Council, media, and other entities based on the data available to them per the agency's statute. It is also used to provide data for the agency annual reports and quarterly and annual agency performance plan reporting. The ability to run queries and develop reports is a useful tool in establishing and reporting trends in critical areas toward prevention efforts. Modifications to the CMS are made by the agency's IT Unit in conjunction with a vendor at cost. This is an ongoing effort. As such, the Action Item from last year's OCME FY23 Performance Hearing questions to develop a "sixth text box that is specifically made to capture the responses of the six questions" is still in progress.

Despite numerous advertisements and postings on both local and national sites, the agency was unsuccessful in filling the vacant medical examiner position due to the following reasons:

1. National shortage of medical examiners

The national shortage of medical examiners coupled with a national increase in case load has led to an overwhelming amount of vacant medical examiner positions. All offices are aggressively competing to fill these positions from the already limited pool of forensic pathologists. This translates to forensic pathologists having numerous options for where they want to work and unfortunately the District has not been able to compete with the successful hiring practices of the other offices. This is reflected in the fact that when posted, only one to two candidates have applied for the position and usually those candidates do not hold the qualifications or board certifications for the position.

2. Salary

The most significant hiring practice that most (and all of the surrounding jurisdictions) have implemented to successfully attract candidates is to significantly increase the salary for medical examiners. Unfortunately, the salaries in the District are not competitive locally, putting OCME at a significant disadvantage. Neighboring jurisdictions (Northern VA, Baltimore, Philadelphia) have all increased their salary so that the most inexperienced ME's (those coming straight out of fellowship) are currently making significantly more (upwards of \$60-100,000) than the base salaries of the agency's most senior pathologists (including the executive level medical examiners) here at OCME.

3. Residency requirement

The position of the Deputy Medical Examiner ("DME") requires the employee to reside within the district which significantly decreases the candidate pool, both in numbers and experience. Candidates have expressed issues with this requirement for a number of reasons ranging from financial ability to safety. Also note that it is usually the youngest of pathologists (those coming out of fellowship who are unwed and do not have children) or elder pathologists (those looking to retire in the near future and are therefore looking to downsize) who do not take issue with the residency requirement because they are looking to enjoy the city / urban life. Those who are in the middle of their careers (practicing for greater than 3 years and are not nearing the retirement age) tend to seek suburban or rural living situations.

All these factors have equally contributed to OCME's inability to successfully fill the vacancies. Also, note that OCME would need an additional ME position (total of six DMEs) to ensure we meet the less than 250 cases standard.
