A BILL

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To amend, on a temporary basis, section 47–362 of the District of Columbia Official Code to require that the Mayor submit all reprogramming requests related to the DC Circulator to the Council for prior approval, and to amend the Department of Transportation Establishment Act of 2002 to require that money from the sale, lease, or transfer of DC Circulator assets be deposited in the DC Circulator Fund and expended to support DC Circulator workers, and to require that the District Department of Transportation coordinate with the Washington Metropolitan Area Transit Authority to determine the feasibility of assuming control of the DC Circulator, providing alternative or additional bus service, or hiring DC Circulator workers at their current pay and seniority status.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the “DC Circulator Transition Temporary Amendment Act of 2024”.

Sec. 2. Section 47–362 of the District of Columbia Official Code is amended by adding a new subsection (j) to read as follows:

“(j) Notwithstanding § 47-361(14), § 47-363(a) shall apply to any reprogramming request, regardless of dollar value, related to the DC Circulator, as described in Title III of the Department of Transportation Establishment Act of 2002, effective March 5, 2007 (D.C. Law 16-225; D.C. Official Code § 50–921.31 *et seq.*)”.

34 Sec. 3. Title III of the Department of Transportation Establishment Act of 2002, effective
35 March 6, 2007 (D.C. Law 16-225; D.C. Official Code § 50–921.31 *et seq.*), is amended to read as
36 follows:

37 “(a) There is established as a special fund the DC Circulator Fund (“Fund”), which shall
38 be administered by the District Department of Transportation (“DDOT”).

39 “(b) All special purpose funds collected from the following sources shall be deposited into
40 the Fund:

41 “(1) All revenue collected pursuant to § 50-921.32 by the District, WMATA, or their
42 agents;

43 “(2) Parking meter revenue from the National Park Service for meters on the Mall;

44 “(3) All monetary gifts intended to be used to assist in the funding of the DC
45 Circulator; and

46 “(4) All money derived from the sale, lease, or transfer of any property, real or
47 personal, related to the DC Circulator, including any vehicles or equipment.

48 “(c)(1) Except as provided in paragraphs (2) and (3), money in the Fund shall be used for
49 the following purposes:

50 “(A) For DDOT to pay for goods, services, property; or

51 “(B) Any other authorized purpose.

52 “(2) Money in the Fund deposited pursuant to subsection (b)(4) shall be used to
53 support any workers, contractors, or employees of the DC Circulator or of Department staff

54 associated with the DC Circulator, including the payment of wages, bonuses, severance pay, or
55 workforce development.

56 “(3) During any period of time in which a contract with WMATA is in effect, money
57 from the payment of fares, the purchase of tickets, and the sale of advertising space by third parties
58 may be, with the written consent of the Chief Financial Officer for the District of Columbia and
59 pursuant to the terms of the contract, deposited in a WMATA interest bearing account for the
60 benefit of the District of Columbia and used by WMATA to offset its costs of contract performance,
61 but only to the extent that Congress has appropriated funds to the District to perform or procure
62 those services; provided, that for a period of 8 months following March 2, 2010, no DC Circulator
63 route shall replace more than 20% of the revenue miles or revenue hours of any WMATA route.”.

64 “(B) Subject to authorization in an approved budget and financial plan, any
65 funds appropriated in the Fund shall be continually available without regard to fiscal year
66 limitation.”.

67 (b) Section 11f (D.C. Official Code § 50–921.36) is amended to read as follows:

68 “Sec. 11f. Coordination with WMATA regarding DC Circulator termination.

69 “The District Department of Transportation shall coordinate with WMATA to determine
70 the feasibility of WMATA:

71 “(1) Assuming control and management of the DC Circulator, maintaining the DC
72 Circulator workforce, and continuing DC Circulator service;

73 “(2) Providing alternative Metrobus routes or additional Metrobus service for riders
74 impacted by planned termination of the DC Circulator; and

75 “(3) Hiring former DC Circulator workers while preserving their rate of pay and
76 seniority.”.

77 Sec. 4. Fiscal impact statement.

78 The Council adopts the fiscal impact statement of the Budget Director as the fiscal impact
79 statement required by section 4a of the General Legislative Procedures Act of 1975, approved
80 October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).

81 Sec. 5. Effective date.

82 (a) This act shall take effect following approval by the Mayor (or in the event of veto by
83 the Mayor, action by the Council to override the veto), a 30-day period of congressional review as
84 provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December 24,
85 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
86 Columbia Register.

87 (b) This act shall expire after 225 days of its having taken effect.
