23	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That, this
24	act may be cited as the "Closing of a Public Alley in Square 5051, S.O. 21-00136, Second
25	Emergency Act of 2024".
26	Sec. 2. (a) Pursuant to section 404 of the District of Columbia Home Rule Act, approved
27	December 24, 1973 (87 Stat. 787; D.C. Official Code § 1-204.04), and consistent with the Street
28	and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law
29	4-201; D.C. Official Code § 9-201.01 et seq.), the Council finds that the portion of public alley in
30	Square 5051, as shown on the Surveyor's plat filed under S.O. 21-00136, is unnecessary for alley
31	purposes and orders it closed with title to the land to vest as shown on the Surveyor's plat.
32	(b) The ordering of this alley closing is contingent upon satisfying the conditions set forth
33	by Washington Gas in the official file for S.O. 20-00136 prior to the recordation of the plat by
34	the Surveyor.
