

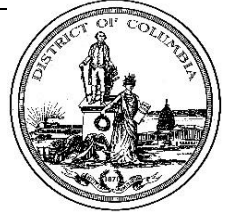

On Friday, November 22, 2024, Councilmember Anita Bonds will hold a public roundtable on PR25-0987 - Office of Employee Appeals Pia Winston Confirmation Resolution of 2024.

The purpose of PR25-0987 is to appoint Pia Winston as a member of the Office of Employee Appeals, filling a vacant seat formerly held by Clarence Labor, for the remainder of an unexpired term to end April 6, 2030. This nomination will be deemed approved on January 9, 2025 unless a resolution of approval or disapproval is introduced.

Persons who wish to testify must register using the Council's Hearing Management System at <https://lims.dccouncil.gov/hearings> or phone the Committee at (202) 724-8198, at least two business days before the hearing. Each witness will receive an individual Zoom invitation for the hearing in a separate e-mail. Witnesses are encouraged to submit an electronic version of their testimony. Testimony should be submitted through the Council's Hearing Management System at <https://lims.dccouncil.gov/hearings> in advance of the hearing. Oral testimony will be limited to 5 minutes for those testifying on behalf of an organization and 3 minutes for those testifying on behalf of themselves. The deadline to register to testify is Wednesday, November 20, 2024 at 5:00 p.m..

If someone is unable to testify at the public hearing, written statements are encouraged and will be made a part of the official record. Written statements should be submitted through the Hearing Management System at <https://lims.dccouncil.gov/hearings> or mailed to the Committee on Executive Administration and Labor, John A. Wilson Building, 1350 Pennsylvania Avenue, N.W., Suite 116, Washington, D.C. 20004. The record will close at 5:00 p.m. Friday, December 6, 2024.
