Council Chairman Phil Mendelson announces a public hearing before the Committee of the Whole on **Bill 25-852**, the “East River Alley Designation Act of 2024,” **Bill 25-876**, the “Dr. Judy Talbert Street Designation Act of 2024,” **Bill 25-923**, the “Louise B. Miller Designation Act of 2024,” **Bill 25-931**, the “Rev. A. Knighton Stanley Way Designation Act of 2024,” **Bill 25-1036**, the “Girl Scouts’ Way Designation Act of 2024,” **Bill 25-1037**, the “DC Legendary Musicians Way Designation Act of 2024,” and **Bill 25-1002**, the Closing of a Portion of a Public Alley and Dedication of Land for Alley Purposes in Square 756, S.O. 24-00310, Act of 2024.” The hearing will be held at **11:00 a.m. on Thursday, December 19, 2024.**

The stated purpose of **Bill 25-852** is to officially designate the public alley system within Square 5755, Lots 830 and 841, located at 1655-1659 W Street, SE, between W Street S.E. and Galen Street, S.E., as East River Alley. The stated purpose of **Bill 25-876** is to officially designate 2465 Alabama Avenue, S.E., between Gainesville Street, S.E. and Hartford Street, S.E., as Reverend Dr. Judy Talbert Street. The stated purpose of **Bill 25-923** is to symbolically designate T Street, N.W., between 12th Street, N.W. and 13th Street, N.W., as Louise B. Miller Way. The stated purpose of **Bill 25-931** is to symbolically designate Iowa Avenue, N.W., between Arkansas Avenue, N.W. and 13th Street, N.W., as Rev. A. Knighton Stanley Way. The stated purpose of **Bill 25-1036** is to symbolically designate the 3000 block of Veazey Terrace, N.W., as Girl Scouts’ Way. The stated purpose of **Bill 25-1037** is to officially designate the north-south alley within Square 441, bounded by 7th Street, N.W., T Street, N.W., Wiltberger Street, N.W., and S Street, N.W. as DC Legendary Musicians Way. An official designation of an alley or public space enables

the placement of addresses, related signage, and possible development. The stated purpose of Bill 25-1002 is to order the closing of a portion of a public alley in Square 756 abutting Lot 47, and the dedication of a portion of Lot 806 for public alley purposes. This closing and dedication will facilitate development.

Those who wish to testify must register using the Council's Hearing Management System at <https://lims.dccouncil.gov/hearings> by **5:00 p.m. on Tuesday, December 17, 2024. Testimony is limited to four minutes.** Witnesses who anticipate needing spoken language interpretation, or require sign language interpretation, are requested to inform the Committee office of the need as soon as possible but no later than five business days before the proceeding by emailing cow@dccouncil.gov. We will make every effort to fulfill timely requests, although alternatives may be offered. Requests received in less than five business days may not be fulfilled. Witnesses will receive instructions on how to participate by Zoom prior to the hearing. Public witnesses may participate in person or virtually via the Internet on the Zoom Video Conference platform. Testimony should be submitted through the Council's Hearing Management System (<https://lims.dccouncil.gov/hearings>) in advance of the hearing. That testimony will be publicly accessible upon Committee review. If you are unable to testify at the hearing, written statements are encouraged and will be made a part of the official record. Statements for the record should be submitted through the Hearing Management System or left by voicemail by calling (202) 430-6948 (up to 3 minutes which will be transcribed). The record will close at 5:00 pm on December 31, 2024.
