A RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve Contract Modification Nos. 13 and 14 to Contract NFPHC-NSD-21-C-00027 between the Not-for-Profit Hospital Corporation, commonly known as United Medical Center (“Hospital”), and Amergis Healthcare Staffing Inc. (formerly Maxim Healthcare Staffing Services Inc) for the provision of nurses in the emergency department, ICU, and telemetry units services and to authorize payment for the services received and to be received under the Contract.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the “Modification Nos. 13 and 14 to Contract NFPHC-NSD-21-C-00027 between the Not-for-Profit Hospital Corporation and Amergis Healthcare Staffing Inc. Approval and Payment Authorization Emergency Declaration Resolution of 2024”.

Sec. 2. (a) There exists an immediate need to approve Modification Nos. 13 and 14 to Contract NFPHC-NSD-21-C-00027 Modifications (“Contract”) between the Not-for-Profit Hospital Corporation (“Hospital”) and Amergis Healthcare Staffing Inc. (formerly Maxim Healthcare Staffing Services Inc) for the provision of nurses in the

39 emergency department, ICU, and telemetry units services, and to authorize payment for
40 the services received and to be received under this Contract.

41 (b) The Council approved the Base Year (Modifications #1 and #2) on June 29,
42 2021, for a total retroactive value of \$3,500,000.00 (A24-115).

43 (c) The Council approved Option Year 1 (Modifications #5-#9) on November 1,
44 2022, for a total retroactive value of \$6,259,863.02 (A24-653).

45 (d) The Council approved Option Year 2 (Modifications #10 and #11) on June 6,
46 2023, for a total retroactive value of \$3,425,000.00 (A25-127).

47 (e) Modification #12 was approved by Council on February 6, 2024, and
48 exercised Option year 3 (December 10, 2023 – December 9, 2024) for the amount of
49 \$3,000,000.00 (A25-401).

50 (f) If Proposed Modification #13 is approved for \$6,000,000.00, the revised total
51 retroactive value of the Option year 3 (December 10, 2023 – December 9, 2024) would
52 have an aggregate value of \$9,000,000.00. This amount would exceed \$1 million in a 12-
53 month period, and therefore Council approval is necessary.

54 (g) If Proposed Modification #14 exercising part of Option Year 4 (December 10,
55 2024 through March 31,2025) is approved for \$3,200,000.00, it would have an aggregate
56 value that exceeds \$1 million in a 12-month period; therefore, Council approval is
57 necessary.

58 (h) Without this approval, Amergis Healthcare Staffing Inc. cannot be paid for
59 these critical services provided and to be provided in excess of \$999,999.99.

60 Sec. 3. The Council determines that the circumstances enumerated in section 2
61 constitute emergency circumstances making it necessary that Modification Nos. 13 and

62 14 to Contract NFPHC-NSD-21-C-00027 between the Not-for-Profit Hospital
63 Corporation and Amergis Healthcare Services, Inc. Approval and Payment Authorization
64 Emergency Act of 2024, be adopted after a single reading.

65 Sec. 4. This resolution shall take effect immediately.
