I then called security to let him know that we had a group of young people going up to the rooftop. He advised that he had already left the property. I went up to the rooftop and asked who they were with They said Trayon but he wasn't present. I let them know that they would have to leave. I came back to the desk and called Mr. White. The young man came down with me. But the others stayed on the roof top on the hammocks.

When I spoke to Mr. White letting him know what was going, he was nonchalant and asked what the problem was. I let him know that they could not be on the roof top without him. He wanted me to let them stay. I told him they couldn't. The young man was respectful and asked if I could go with him up to let his friends know they had to leave and to get them. I escorted him back up and escorted them down and out of the building. The young man let me know that a resident had let him up there to the sky terrace.
