On Friday, March 14, 2025, Matthew Frumin, Chairperson of the Committee on Human Services, will convene a Public Roundtable to consider PR26-0118, the “Board of Library Trustees Antonio Williams Confirmation Resolution of 2025”, PR26-0119, the “Board of Library Trustees Andrew Trueblood Confirmation Resolution of 2025”, and PR26-0120, the “Board of Library Trustees Maria Peace Confirmation Resolution of 2025”. The roundtable will be held in a hybrid format, in both Room 412 of the John A. Wilson Building and on the Zoom virtual platform, beginning at 1:00 p.m.

Proposed Resolution 26-0118, the “Board of Library Trustees Antonio Williams Confirmation Resolution of 2025”, would confirm the reappointment of Mr. Antonio Williams to the Board of Library Trustees, for a term to end January 5, 2030.

Proposed Resolution 26-0119, the “Board of Library Trustees Andrew Trueblood Confirmation Resolution of 2025”, would confirm the reappointment of Mr. Andrew Trueblood to the Board of Library Trustees, for a term to end January 5, 2030.

Proposed Resolution 26-0120, the “Board of Library Trustees Maria Peace Confirmation Resolution of 2025”, would confirm the reappointment of Ms. Maria Peace to the Board of Library Trustees, for a term to end January 5, 2030.

The Committee invites the public to provide oral and written testimony. Members of the public may sign up to testify using the Hearing Management System at <https://lims.dccouncil.gov/hearings/>. **Online registration will close 2 business days (48 business hours) before the roundtable.** If you cannot register to testify online, please contact Elias Benda, Senior Legislative Advisor, for further assistance at ebenda@dccouncil.gov or (202) 679-6358.

Registered witnesses will receive an e-mail from the Committee with instructions on how to testify and register for a Zoom link before the roundtable. The first representative to speak on behalf of an organization will have five (5) minutes to testify. Subsequent representatives of the same organization will have three (3) minutes to testify. All other members of the public will have three (3) minutes to testify. Advisory Neighborhood Commissioners will have five (5) minutes to testify.

Witnesses who anticipate needing spoken language interpretation or who require closed captioning are asked to communicate with the Committee about how it can best help them participate as soon as possible. If a witness who requires accommodations to participate in a hearing reaches out to the Committee **fewer than five (5) business days before the roundtable, it may no longer be possible to arrange for an accommodation.** An alternative may be offered.

All witnesses are strongly encouraged to provide written testimony by uploading it to the Hearing Management System. **The record will close for all forms of testimony at the end of the business day on Friday, March 14, 2025.**
