At the request of the Mayor, I request that the following measures be agendized for the May 6, 2025 Legislative Meeting.

- **Contract No. CW108863 with La Clínica del Pueblo, Inc. Approval and Payment Authorization Emergency Declaration Resolution of 2025**
- **Contract No. CW108863 with La Clínica del Pueblo, Inc. Approval and Payment Authorization Emergency Act of 2025**
- **La Clínica del Pueblo, Inc. E-Filing**

There exists an immediate need to approve Contract No. CW108863 with La Clínica del Pueblo, Inc., and Modification Nos. M0001, M0002, and M0003 thereto, and to authorize payment for the goods and services received and to be received under the contract and modifications. On July 6, 2023, the Office of Contracting and Procurement (“OCP”), on behalf of the Department of Behavioral Health, executed Contract No. CW108863 with La Clínica del Pueblo, Inc., for substance use disorder outpatient treatment services, in the not-to-exceed (“NTE”) amount of \$700,000 for the period July 6, 2023, through July 5, 2024. On July 3, 2024, via Modification No. M0001, OCP exercised option year one of Contract No. CW108863 in the NTE amount of \$700,000 for the period July 6, 2024, though July 5, 2025. Modification No. M0002 increased the NTE amount of option year one of Contract No. CW108863 by \$280,000, from \$700,000 to \$980,000. Modification No. M0003 will increase the NTE amount of option year one of Contract No. CW108863 by \$620,000, from \$980,000 to \$1,600,000.

- **Modification 3 to Contract No. NFPHC-ER-23-C between the Not-for-Profit Hospital Corporation and George Washington University Medical Faculty Associates, Inc., Approval and Payment Authorization Emergency Act of 2025**

There exists an immediate need to approve Modification 3 to Contract No. NFPHC-ER-23-C with George Washington University Medical Faculty Associates, Inc., and to authorize payment for goods and services received and to be received under the modification. Modification 3 is a closure contract modification, which among other things, seeks to extend the partial exercise of Option Year 2 of the contract from April 1, 2025, through April 15, 2025, in the not-to-exceed amount of \$291,492.35, which if approved, would bring the total not-to-exceed value of Option Year 2 to \$3,789,400.61, for the period of October 1, 2024, through April 15, 2025.

- **Modification No. 2 to Contract NFPHC-MS-23-C-00054 between the Not-for-Profit Hospital Corporation and Northrium Health LLC Approval and Payment Authorization Emergency Act of 2025**

There exists an immediate need to approve Modification 2 to Contract NFPHC-MS-23-C-00054 with Northrium Health, LLC, and to authorize payment for goods and services received and to be received under the modification. Modification 2 is a closure contract modification, which among other things, seeks to extend the partial exercise of Option Year 1 of the contract in the not-to-exceed amount of \$64,119.43 for the period of April 1, 2025, through April 15, 2025, which if approved, would bring the total not-to-exceed value of Option Year 1 to \$1,090,303.42, for the period of August 1, 2024 through April 15, 2025.

- **Modification No 4 to Contract No. NFPHC-NUR-23-C-00039 between Not-for-Profit Hospital Corporation and Aya Healthcare, Inc. Approval and Payment Authorization Emergency Act of 2025**

There exists an immediate need to approve Modification 4 to Contract No. NFPHC-NUR-23-C-00039 with Aya Healthcare Staffing Inc., and to authorize payment for supplemental nurse staffing services received. Proposed Modification 4, which among other things, seeks to extend the period of Option Year 2 to April 15, 2025, without increasing the value beyond the Council’s retroactively approved Modification 3 amount of \$1,200,000.00 (A26-0016). Retroactive Council approval of Modification 4 covers Aya payments for costs over \$1,000,000 incurred during the extended period, January 2, 2025 through April 15, 2025.

- **Modification No 15 Contract NFPHC-NSD-21-C-00027 with Amergis Healthcare Staffing Inc. Approval and Payment Authorization Emergency Act of 2024**

There exists an immediate need to approve Modification 15 to Contract NFPHC-NSD-21-C-00027 with Amergis Healthcare Staffing Inc., and to authorize payment for goods and services to be received. Proposed Modification 15 is a contract modification, which among other things, seeks to extend the period of Option Year 4 to April 15, 2025, without increasing the value beyond the Council's retroactively approved Modification 14 amount of \$3,200,000.00 (A25-672). Retroactive Council approval of Modification 15 covers Amergis payments for costs over \$1M incurred during the extended period, December 10, 2024 through April 15, 2025.
